In compliance with the requirements of F.S. Chapter 617, the undersigned hereby act as incorporators in adopting and filing the following articles of incorporation for the purpose of organizing a not-for-profit business corporation.

**ARTICLE I**

The name of the Corporation is: **PEACE, LOVE, EAT, INC.**

**ARTICLE II**

The street address of the principal office of the Corporation is: 10620 Griffin Road, Suite B108, Davie, Florida 33328.

**ARTICLE III**

PEACE, LOVE, EAT, INC. is organized exclusively for charitable and educational purposes to teach healthy easy recipes via hand-on cooking programs and demonstrations to children who are in foster care and to the elderly. The Corporation will also facilitate and manage donations of food, food preparation supplies and food service professionals to support the charitable and educational purposes of the not-for-profit Corporation.

**ARTICLE IV**

All corporate powers shall be exercised by or under the authority of, and the business of the Corporation shall be managed under the direction of the Board of Directors. The number of the initial Board of Directors for the Corporation shall be as provided for in the Corporation's Bylaws. It is further provided that the number of Directors may be increased or decreased, as provided in the Corporation's Bylaws. Such Directors are to be elected or appointed in the manner proved for by the Corporation's Bylaws.

**ARTICLE V**


