



# Article III TERM OF EXISTENCE

This corporation shall have perpetual existence commencing upon the filing of these Articles.

# Article IV PURPOSE

The corporation is organized as a non-profit-corporation exclusively for charitable, religious, educational and scientific purposes, including such purposes, the making of distributions to organizations that qualify as exempt organizations under 501 (c) (3) of the IRS code, or corresponding sections in any future federal tax code, Specifically, the corporation is organized to provide information and sensitize our community about organ donation and transplantation as a way to save lives.

### Article V ACTIVITIES

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaing on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal Income Tax under section 501(c)(3) of the IRS Code, or corresponding section of any future federal tax Code, or (b) by a corporation, contributions to which are

deductible under 170(c)(2) of the IRS Code, or corresponding section of any future federal tax code.

### Article VI DISSOLUTION

Upon the dissolution of the corporation, its assets shall be distributes for one or more exempt purposed within the meaning of section 501(c)(3) IRS Code, or corresponding section of any future Federal Tax Code, or shall be distributed to the federal government or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation operates, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

### Article VII INCOME

The corporation shall distribute its net income for each tax year at such time and in such manner as not to become subject to the tax on undistributed income proposed by Section 4942 of the IRS Code, or corresponding section of any future federal tax code.

### Article VIII SELF DEALING

The corporation will not engage in any act of self dealing as defined by Section 4941 of the IRS Code, or corresponding section of any future federal tax code.

### Article IX EXCESS BUSINEESS HOLDINGS

The corporation shall not retain any excess business holdings as defined by

The corporation shall not make any investments in such manner as to become subjet to the tax on undistributed income proposed by Section 4944 of the IRS Code, or corresponding section of any future federal tax code.

### Article XI EXPENDITURES

The corporation shall not make any taxable expenditures as defined by Section 4945 of the IRS Code, or corresponding section of any future federal tax code.

### Article XII CUALIFICATION OF MEMBERS

The qualifications for members and manner of their admission shall be regulated by By-Laws of the corporation.
