ARTICLE 111

CORPORATE PURPOSE

PURPOSE: The purposes for which the corporation is organized are exclusively religious, charitable, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

The purposes for which the ministry is organized are as follows:

- To disseminate the Gospel of Jesus Christ and the Word of God to the end that people may be evangelized and believers may be conformed to the image of Jesus Christ (Mark 16:15-16, Isaiah 6:8, Acts 13:47, 11 Corinthians 5:20); to regularly assemble for fellowship to worship God in Spirit and in truth (Hebrews 10:25) and to cooperate in the building up of the whole body of Christ (Ephesians 2:19-22).
- (b) To provide basic New Testament discipleship to all who are approved for this purpose by the Elders. (Acts 6:7, 11:26, 14:20-23)
- To print, publish, and distribute and sell books, magazines and other literature in connection with the purposes of this corporation; to sell, record and reproduce tapes, radio, and television programs in connection with the purposes of this corporation to produce and distribute radio and television programs (Deuteronomy 31:19; I Chronicles 16:23-24; Psalm 68:4; Revelation 14:2).
- To establish, maintain and conduct seminars for the instruction of children and adults for religious instruction. (Psalms 40:9-10; 1 Peter 4:6; John 14:26)
- To conduct Christian retreats, tours, seminars, camps, and to promote the Gospel of Jesus Christ through the various media. (Jeremiah 3:15; Psalms 32:8, 37:30; Proverbs 9:9, 15:22)
- To foster entrepreneurial missionary activities throughout the United States (1)and other countries. (Deuteronomy 8:17-18, 11:13-14, 30:9; I Kings 2:3; Proverbs 14:23; Ecclesiastes 5:9,18-19; Isaiah 48:17; 1 Thessalonians 4:11-12)
- (g) To establish and raise up churches and pastors to lead them; to provide spiritual oversight to those churches and pastors who desire the oversight and to provide spiritual accountability for the conduct of independent churches and

- (h) To propagate the Word of the Gospel through seminars, radio, tv, establishment of Church literature, and other forms of mass media for the purpose of educating the individual in the Word of God. (Psalms 96:10; Proverbs 13:17; Mark 13:10; Acts 13:47)
- (i) To carry on charitable work for the poor and lost (Leviticus 25:35; Matthew 25:34-40; Galatians 6:10; Mark 14:7) such as:

Feed the Hungry Soup Kitchen, Food Pantry, Clothes Closet (Matthew 25:35;

Psalm 146:7; Luke 3:11, 4:18)

Prison Ministry (Psalm 142:7; I Peter 3:19)

After-care Center for Released Prisoners (Job 3:18; Psalm 69:33; Isaiah 49:9-10)

Sick and Shut-in Ministry (James 5:14-15: Mark 16:18)

Unwed Mother's Home (Luke 1:39-40,56)

Abused Wives and Children's Home (Exodus 22:22-24; Deuteronomy 10:18; Acts

6:1: 1 Timothy 5:3-12.16)

Housing for the Homeless and Runaways (Leviticus 25:35; Proverbs 19:17; Luke 3:11; II Corinthians 8:14-15)

Care for and assist handicapped individuals (Leviticus 19:32; Isaiah 35:5; Mark 7:37; Luke 7:32,14:13-14)

To provide ministry to homosexuals and prostitutes, so they may be taught the Gospel of Jesus Christ (I Corinthians 1:27-31, 6:9-11; Hebrews 10:22; Luke 14:12-24; Matthew 22:2-10, John 8:1-11).

To provide homes for the aged (Leviticus 19:32; Psalm 71:9; Isaiah 45:20-22).

To establish and support orphanages for abandoned and deserted children (Numbers 3:13; Psalms 127:3; Proverbs 22:6; Isaiah 54:1; Mark 10:14; Luke 18:16)

To provide child placement services and adoptive services (Psalm 127:3; Isaiah 54:1; Mark 10:14; Numbers 3:13).

To establish a credit union for members of the church (Psalm 72:4, 112:5:

Malachi 3:10; Deuteronomy 15:7-11, 28:12,44; Matthew 5:42; Proverbs 3:9; Nehemiah 11:38).

Housing for those with addictive behavior (Luke 4:18).

Drug and Alcohol Program (Isaiah 5:11, 19:14,20; Habakkuk 2:15; Joel 2:32; Matthew 9:12; Psalm 121:2).

The mentally disturbed (Matthew 4:24, 17:15).

(j) To establish an apostolic mission (Matthew 10:7, Luke 9:2, I Corinthians 1:17-18, I Timothy 1:11, Mark 6:13) providing for church planting (Acts 11:21, 15:41, 16:5, 18:8-11), establishing spiritual covering for and authority over members of the five-fold ministry and groups seeking association in the fellowship (Acts 15:6.22-29, I Corinthians 4:17, 9:2, 12:28, I Thessalonians 3:1-2), and setting qualified men as recognized by God in the office given them by God (I Timothy 4:14, II Timothy 1:6, 2:2, Titus 1:5, Acts 5:5-6, 13:1-3, 14:23).

- (k) To establish and maintain an educational institution and not for pecuniary gain; for the establishment, maintenance and support of a private Christian elementary and secondary schools (Christian Academy) at which both charity and pay students shall be received; for the establishment, maintenance, and support of a private Christian day care center and nursery school (Mark 10:14; Luke 18:16-17) at which both charity and pay students shall be received.
- (1) To provide for and make available the following on a national and international basis:
- 1. To promote, foster, encourage and exhort members of the five-fold ministry, ministers, ministries of helps. Christian workers and church workers through instructional seminars and workshops, and fellowship oriented programs in order to perpetrate spiritual growth and increase knowledge, wisdom and understanding, and to provide for a season of refreshing for the whole man, spirit, soul and body. (Acts 15)
- 2. To certify, license and ordain men of God into positions of ministry and ministry of helps from within and out of the local church based upon calling, education and training and to oversee and evaluate spiritual growth and maturity. (Acts 6:1, 11:29)
- (a) To provide for the certification of Christian workers. (I Corinthians 8:4)
- (b) To license men called of God as ministries of helps and to provide the proper training, instruction, and education to these men for subsequent entry into the five-fold ministry. (I Corinthians 12:28, Luke 1:54, Acts 20:35, I Timothy 6:2)
 - (c) To ordain men called of God who are fully trained, thoroughly furnished, and properly educated to assume positions of responsibility in the five-fold ministry according to those endeavors which God has called them to do. (Ephesians 4:11, I Corinthians 12:28) To ordain ministers and Christian workers to the edification and the unity of the Body of Christ. (I Chronicles 9:22-23; Titus 1:5; I Corinthians 7:17; Acts 14:23)
- (d) To review the performance and progress of those previously certified, licensed or ordained, and to renew certifications, licenses, and ordinations based upon spiritual growth and maturity as reflected by experience and progress in the Word of God, and spiritual application of wisdom, knowledge and understanding. (I Corinthians 12:28, Colossians 1:9)
- 3. To provide and foster continuing education programs as a basis for inspiration, a sharing of information and the dissemination of applicable information and to provide programs of instruction to the benefit of all involved in the Christian faith, and to provide exhortation for the sake of the Gospel, the Kingdom of God and the Christian faith. (II Timothy 1:13, 2:2, Proverbs 9:9)
- 4. To foster unity among various interdenominational ministries; to provide a forum for exchange of information and ideas concerning the work of the ministry; to periodically hold conventions for members of the five-fold ministry, ministers of

helps. Christian workers, and church workers for the purpose of continuing education in how to operate a ministry within the framework of the Kingdom of God, and to provide assistance, guidance and counseling to those working in or relating to any aspect of Christian ministry. (Ephesians 4:12-13, Acts 15)

- 5. To associate together for the mutual benefit of ministers, clergy, pastors, evangelists, teachers and those associated in any ministerial associations or societies for their mutual benefit as such, and to assist them in the establishment, exhortation and edification of churches, religious organizations, societies and self; to provide continuing education, seminars, retreat and instructional programs to aid and assist in continuing spiritual growth and to disseminate information relative to matters pertaining to the Christian faith and religion. (I Corinthians 14:12, Psalms 37:30, Proverbs 15:22)
- 6. To accept transfer of other individuals who are ordained by other recognized ministerial bodies, associations and organizations; to interest and unite people of all races, sexes, creeds, and national origins to the end that a nobler manhood and womanhood may be developed and a more perfect love of home, family, country, and church may be fostered.
- 7. To perpetrate and stimulate the physical and spiritual growth of the local church and to train and assist those within the local church who are called of God into positions of workers, ministries of helps, into the five-fold ministry. (I Peter 4:6, John 14:26)
- (m) To conduct pastor training seminars for national pastors; and to conduct all missionary outreach programs necessary to the dissemination of the Word of God throughout the world. (Luke 6:40; Psalms 32:8; Proverbs 1:5)
- (n) To establish auxiliaries, clubs, and societies of a religious nature and to promote and encourage Christian fellowship between its members (Acts 15:41, 16:5)
- (o) To print, publish, distribute and circulate on a national and international basis, books, pamphlets, periodicals, papers, newsletters, and magazines in connection with the kingdom of God and the propagation of the Gospel of Jesus Christ. (Psalms 68:11; Acts 13:49; Exodus 31:18; Mark 1:45, 13:10)
- (p) To support the religious activities of nonprofit religious organizations whose primary objective is to engage in the conduct of religious worship. (I Corinthians 9:9-10, 16:1-4; II Corinthians 9:6-7, 11-13)
- (q) To own and operate Radio and Television Stations for the purpose of the dissemination of the Gospel of Jesus Christ through word and music (Psalms 96:10; Proverbs 13:17; Mark 13:10; Acts 13:47; Deuteronomy 31:19; I Chronicles 16:23-24; Psalms 68:4; Revelation 14:2)
- (r) To operate under the name as set forth in Article I above; to adopt and assume names in the furtherance of its nonprofit, tax-exempt purposes (Genesis 17:5, 32:28;

Acts 13:9; Matthew 1:23; Revelation 2:17); to exercise such other and incidental powers as may reasonably be necessary to carry out the purposes for which the church is established, provided that such incidental powers shall be exercised in a manner consistent with its tax exempt status as a religious organization as set forth in Section 501(c)(3) of the internal Revenue Code of 1986 as amended, of the United States of America.

The several clauses contained in this Article shall be constructed both as purposes and powers and powers and the statements contained in each clause, shall except where otherwise expressed, be in no wise limited or restricted by reference to or inference from the terms of any other clauses, but shall be regarded as independent purposes and powers.

- (s) To join, merge or unite with any other church or other religious society having the same ideals, aims and purposes of this organizations; to associate and cooperate freely with other churches and with missionary organizations and branches as a free and independent fellowship body in accord with its own conscience and the wisdom of God, as the ministry perceives it to be, but in every case and in every act and in practice or association does and shall do so as a free ministry, always retaining its sovereignty and independence, and in no case whatsoever as an act of subjection nor precedent or amenability nor as an active or passive or implied affiliation nor in any as relinquishing its perpetual legal independence and sovereignty as a ministry. (Acts 5:12-14, I Corinthians 1:10, 6:17, Ephesians 4:16)
- (1) To receive tithes, offerings, and property by gift devise or bequest subject to the laws relating to the transfer of property by gift or will. (Acts 4:34-37; II Chronicles 31:3-7; Leviticus 27:30; I Corinthians 16:1-2; Luke 6:38)
- (u) To act as Trustee under any trust incidental to the principal objects of the ministry and to receive, hold, administer and expend funds and property subject to such trust. (Acts 4:34-37)
- (v) To purchase or otherwise acquire lands and interest in lands whether leasehold, in fee, or otherwise, situated within or without the State of Florida wherever the opportunity may present itself and to own, hold, improve by building or otherwise and to deal in and with or to lease out or otherwise use for corporate and income purposes, or to encumber, sell and dispose of any such real estate or improvements or any interest therein, or to lease the same either as landlord or tenant; and to purchase construct, and otherwise acquire and to own, maintain, and operate buildings of any character, for the corporate purposes.
- (w) To employ qualified counsel and other necessary personnel to carry out the purposes of this ministry. (Titus 3:13; James 5:4)
- (x) To purchase, to receive by way of gift, subscribe for, invest in, and in all other ways, acquire, import, lease, possess, maintain, handle on consignment, own.

hold, or investment or otherwise use, enjoy, exercise, operate, manage, conduct, perform, make, borrow, let, lend, report, mortgage, pledge, deed in trust, hypothecate, encumber, transfer, improve, equip, repair, alter, fabricate, assemble, build, construct, operate, manufacture, plant cultivate, produce, market, and in all other ways (whether like or unlike any of the foregoing), deal in and with property of every kind and character, real, personal or mixed, tangible or intangible wherever situated and however held, including, but not limited to money, credits, chooses in action, securities, stocks, bonds, warrants, script, certificates, debentures, mortgages, motes, commercial paper and other obligations and evidences of interest in or indebtedness of any person, firm, or documents of title, and accompanying rights, and every other kind and character of personal property, real property (improved or unimproved), and the products and avails thereof and every character of interest therein and appurtenance thereto including but not limited to. mineral, oil, gas, and water rights, all or any part of any going business and its incidents, franchises, subsidies, charters, concessions, grants, rights, powers, or privileges, granted or conferred by any government or subdivision or agency thereof and any interest in or part of any of the foregoing and to exercise in respect thereof all of the rights, powers, privileges and immunities of individual owners holders thereof (Ezra 8:28)

- (y) To further all religious and charitable work and for such purposes to adopt and establish Bylaws, rules, regulations in accordance with the law and not inconsistent with this Articles of Incorporation. (Joshua 1:7-8, Habakkuk 2:2-3, Romans 7:12, 10:4)
- (z) To do all those things allowed and permitted to be done by religious corporations under law and specifically those set forth in the Florida Not for Profit Corporation Code.

ARTICLE IX. EXEMPT STATUS AND DISSOLUTION

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code.

No part of the net earnings of the corporation shall inure to the benefit, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of its purposes.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future federal tax code or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986 or any other corresponding provision of any future federal tax code.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the

corresponding section of any future federal tax code. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE X MEMBERSHIP

The conditions and regulations of membership and the rights and other privileges of membership shall be determined by the Bylaws, with membership being eligible to all those who give evidence of their faith in the Lord Jesus Christ and who voluntarily subscribe to its tenants of faith and agree to be governed by its Constitution and Bylaws. This Corporation shall issue no stock.

This corporation shall have members.

ARTICLE XI LIABILITY

No member of HEAVEN TO EARTH MINISTRIES, INC. shall be liable for its debts nor shall any members property be so liable.

ARTICLE XII MANAGEMENT OF CORPORATE AFFAIRS

The affairs of the corporation shall be managed by officers elected by the Board of Directors at its annual meeting. The officers shall serve until the next annual meeting of the Board of Directors, unless removed earlier in accordance with the Bylaws.

The general officers of the corporation shall be the President, Vice-President, Secretary and Treasurer.

The principal duties of the President shall be to preside at all meetings of the members of the Board of Directors and to the general supervision of the church. He shall be the Chairman of the Board of Directors.

The principal duties of the Vice-President shall be to discharge the duties of the President in the event of the absence or disability, for any cause whatsoever, of the President.

The principal duties of the Secretary shall be to countersign all deeds, leases, and conveyances executed by the church, affix the seal thereto and to such other papers as shall be required or directed to be sealed, and to keep a record of the proceedings of the Board of Directors, and to safely and systematically keep all books, papers, records, and documents belonging to the corporation and the church, or in any way pertaining to the business thereof, except the books and records incidental to the duties of the Treasurer.

The principal duties of the Treasurer shall be to keep an account of all monies, credits and property of any and every nature of the church which shall come into his hands, and to keep an accurate account of all monies received and disbursed and of proper vouchers for monies disbursed and to render such accounts, statements, and inventories of monies received and disbursed and of money and property on hand and generally of all matters pertaining to his office, as shall be required by the Board of Directors.

The Board of Directors may provide for the appointment of such additional officers as they may deem for the best interest of the church.

Whenever the Board of Directors may so order, any two officers, the duties of which do not conflict, may be held by one person.

The officers shall perform such additional or different duties as shall from time to

time be imposed or required by the Board of Directors, or as may be prescribed from time to time by the Bylaws.

ARTICLE XIII. BYLAWS

The Bylaws of HEAVEN TO EARTH MINISTRIES, INC. shall be adopted and amended by the Board of Directors.

ARTICLE XIV. DECLARATION OF ASSETS

The property of this corporation is irrevocably dedicated to religious and charitable purposes, and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof, or to the benefit of any private individual.

ARTICLE V. AMENDMENTS

Amendments to these Articles of Incorporation, may be proposed by a resolution adopted by the Board of Directors. After notification to the members of the Board of the proposed amendment, such amendment shall be adopted by the Board of Directors by an affirmative vote of at least two-thirds of the Directors present and voting at a meeting at which a quorum is present.

Any amendment to these Articles of Amendment must be approved in writing by SAMUEL R. HASHIM before they will be considered valid as passed by the Board of Directors. Should such approval not be received, passage by the Board of Directors will be of no force and effect.
