ARTICLE III:

1. **PURPOSE CLAUSE:** The Charitable Life Endowment Assisting Teen Soccer, Inc., is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The general purpose for which the corporation is organized is to:

(i) operate a comprehensive program for the education, training and development of economically challenged youth soccer players inclusive of national competitive play;

(ii) provide counseling and assistance with the identification, pursuit and exposure to domestic and international career development opportunities leading to scholarships to institutions of higher education or recruitment by professional leagues;

(iii) conduct fundraising events and receive charitable donations in support of training, program development and in further support of the not-for-profit corporation's operations; and

(iv) cultivate relationships with media outlets, local and national sponsors, partners, affiliates, community leaders and the local community for the advancement of the youth soccer players and the not-for-profit corporation's purpose.

2. **DISSOLUTION CLAUSE:** Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future Federal Tax Code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
