Article VIII

The Mekong College and Seminary is organized and operated for the following general purposes:  
exclusively for charitable, religious, educational and scientific purposes, including, for such purposes,  
the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3)  
of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article IX

Notwithstanding any other provision of these articles, the Mekong College and Seminary shall not  
carry on any other activities not permitted to be carried on (a) by a Mekong College and Seminary exempt  
from Federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section  
of any future federal tax code, or (b) by a Mekong College and Seminary, contributions to which are deductible  
under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article X

No part of the net earnings of the Mekong College and Seminary shall inure to the benefit of, or be distributable to its  
members, trustees, officers or other private persons, except that the Mekong College and Seminary shall be authorized and  
empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of  
section 501(c)(3) purposes. No substantial part of the activities of the Mekong College and Seminary shall be the carrying  
on of propaganda, or otherwise attempting to influence legislation, and the Mekong College and Seminary shall not  
participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of  
or in opposition to any candidate for public office.

Article XI

Upon the dissolution of Mekong College and Seminary, assets shall be distributed for one or more exempt purposes  
within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal  
tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.


