Article IX:

- 1. No part of the activities of the corporation shall be carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by IRC section 501 (h) or participating in, or intervening in (including the publication or distribution of statements), any political campaign on behalf of any candidates for public office.
- 4. In the event of dissolution, all of the remaining assets and property of the corporation shall after necessary expenses, thereof be distributed to another organization exempt under section 501 (c)(3) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent federal tax laws.
- 5. In any taxable year in which the corporation is a private foundation as described in section 509 (a) of the Internal Revenue Code of 1986, the corporation shall distribute its income for said period at such time and manner as not to subject it to tax under Section 4942 of the Code and the corporation shall not (a) engage in any act of self-dealing as defined in Section 4941(d) of the Code, (b) retain any excess business holdings as defined in Section 4943(c) of the Code, (c) make any investments in such manner as to subject the corporation to tax under section 4944 of the Code, or (d) make any taxable expenditures as defined in section 4945(d) of the Code or corresponding provisions of any subsequent Federal tax laws.
