

RESTATED ARTICLES OF INCORPORATION OF CHILDREN'S HOPE, INC.

The undersigned hereby makes, subscribes, acknowledges and files these Restated Articles of Incorporation for a not-for-profit corporation under the laws of the State of Florida.

ARTICLE I

<u>Name</u>

The name of the corporation formerly the "Foster Parents Association of Palm Beach County, Inc." is hereafter to be CHILDREN'S HOPE, INC.

ARTICLE II

Duration

The corporation shall have perpetual existence. Notwithstanding any other provision of these Articles, in the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986, as amended, or to the Federal, State or local government for exclusive public purpose.

ARTICLE III

Purpose

A. The general purpose for which the Association is formed is to operate exclusively for such purposes as will qualify it as an exempt organization under Sections 501(c)(3) and (6) of the Internal Revenue Code of 1954 or corresponding provisions of any subsequent Federal Tax Law, including, for such purposes, the making of distribution to organizations qualifying as tax-exempt organizations under that code.

Notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986, as amended.

- B. The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literay and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended.
- C. Notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended.

ARTICLE IV

Principal Business Address

The principal business address of the Corporation shall be 1300 N. Florida Mango Road, #21, West Palm Beach, FL 33409.

ARTICLE V

Office of Registered Agent

The street address of the current registered office of the Corporation is 11380 Prosperity Farms Road, #114, Palm Beach Gardens, FL 33410. The name of the Registered Agent at such address is Julianne R. Frank.

ARTICLE VI

Board of Directors

The Board of Directors shall consist of nine members. The number of Directors may be increased or decreased from time to time by the By-Laws, but shall never be less than three. The method of election of Directors shall be as stated in the By-Laws.

Directors' Management Powers

All corporate powers shall be exercised by or under the authority of, and business affairs of the corporation shall be managed under the direction of, the Board of Directors, subject to

the terms specifically set forth in the By-Laws of this Corporation.
