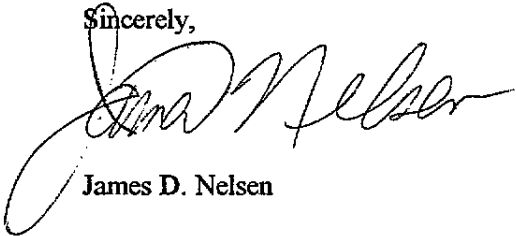

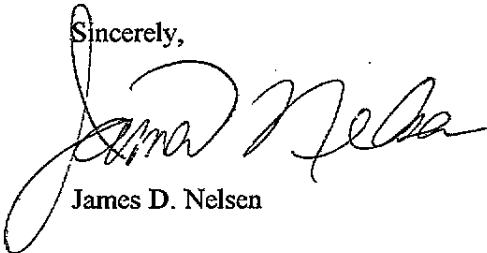

JACKSONVILLE REEF RESEARCH TEAM, INC.

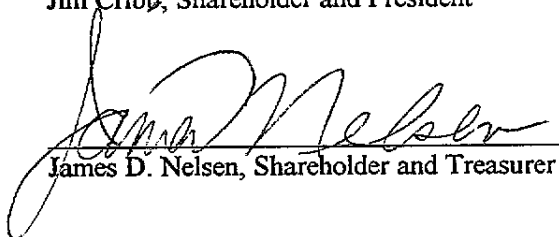
All other provisions of the Articles of Incorporation of this corporation shall remain unchanged as originally adopted.
