THIS IS TO CERTIFY THAT:

FIRST: These Articles of Amendment amend the Articles of Incorporation (the "Articles") of SAWCC, Inc. (the "Company").

SECOND: The Articles of the Company were filed with the Florida Department of State on October 14, 1986, as amended by those certain Articles of Amendment to Articles of the Company filed with the Florida Department of State on December 23, 1998, all under Document Number N17309.

THIRD: Article 1, Section 1 of the Articles is again amended, to read as follows:

The name of the organization shall be THE SHELTER FOR ABUSED WOMEN & CHILDREN, INC.

FOURTH: The amendment was approved and adopted by a duly noticed special meeting of the Board of Directors held on October 18, 2011. The amendment was adopted by a majority vote of the Board of Directors present at the meeting. There are no members entitled to vote on the amendment.


