## To Whom It May Concern:

This correspondence will serve as a request, along with our attached, Not-For-Profit UBR, for reinstatement of our Corporate Status, waiver of the Reinstatement fee, and amendment of our documents to name a responsible party as our Resident Agent who will prevent this problem from arising in the future. Let me explain, further.

We are a small group of athletes who are attempting to promote interest in athletic competitions among our South Florida youth and adult populations. Primarily, we are Triathletes. Last year, we ran a series of youth Triathlons, for boys and girls in age groups from 8 to 15. We held clinics for children and adults to help them learn about this new sport and to help them prepare and train for competition. We are promoting physical and mental health, and an alternative to the negative influences which are confronting them daily.

Several years ago, we elected a new president, Bob Marren. He undertook many duties and worked hard for BEST. Unfortunately, some disagreements arose and he chose to resign from his position and his membership. When the time came to return the BEST paperwork and books, he was unable to provide us with everything. Even worse, when he received—if he did receive—the notices for the Annual Statements, he did not provide them to any current officer or member. Consequently, Annual reports have not been filed for 2001 or 2002. I am enclosing a check for \$122.50 to pay the Filing fees for those two years. The problem is that this amount already represents a substantial percentage of our current treasury, and we are requesting a WAIVER of the actual Reinstatement fee of \$175.00, which will be an EXTREME hardship.

We try to sponsor two or three races per year, here in S. Florida, run a few clinics for other athletes or people thinking of becoming athletes, and we volunteer our time. Any money we raise is used for two or three annual picnic/parties, and we invite the local athletic community. In short, we are asking for any consideration you may give us. Thank you.
