

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF VILLA SAN REMO HOMEOWNERS ASSOCIATION, INC.

Pursuant to Sections 617.1006 and 720.306, Florida Statutes, this undersigned Florida not for profit corporation adopts the following Amendment to its Articles of Incorporation.

FIRST: Amendment Adopted: Amendment to the Articles of Incorporation. Please see attached Exhibit "1".

SECOND: The attached Amendment to the Articles of Incorporation was approved by two-thirds (2/3) vote of the Board of Directors and the affirmative vote of sixty-six and two-thirds percent (66 2/3%) of the total votes of the membership as an amendment to the Articles of Incorporation of Villa San Remo Homeowners Association, Inc. at a duly called meeting on January 26, 2006 and the number of votes cast for the Amendment to the Articles of Incorporation was sufficient for approval.

AMENDMENT TO THE ARTICLES OF INCORPORATION OF VILLA SAN REMO HOMEOWNERS ASSOCIATION, INC.

As used herein, words underlined are added and words hyphened through are deleted.

Article VII of the Articles of Incorporation shall be amended as follows:

DIRECTORS

The affairs of this Association shall be managed by a Board of not less than three (3) nor more than five (5) Directors, who <u>must be need not</u> be members of the Association. The first Board of Directors shall be comprised of three (3) persons. The number of Directors (within the limits of not less than three (3) nor more than five (5) may be changed by amendment of the Bylaws of the Association. The names and addresses of the persons who are to act in the capacity of Directors until the selection of their successors are:

At the first annual meeting, the members shall elect three Directors for a term of one year, and at each annual meeting thereafter the members shall elect Directors to serve for a term of one year. Directors shall be elected to terms of office as provided in the By-Laws.
