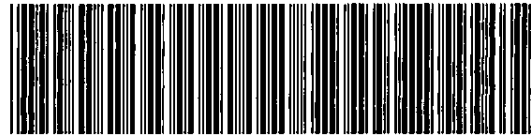

**PLAN OF DISTRIBUTION
WITHLACOOCHEE WORKFORCE DEVELOPMENT AUTHORITY, INC.**

1. Introduction. This plan sets forth the Distribution Plan (hereinafter "Plan") adopted by the Directors of the Withlacoochee Workforce Development Authority, Inc. ("WWDA") at a Special Meeting of the Board on July 28, 2011.

2. Liabilities and Obligations. All liabilities and obligations of WWDA shall be paid and discharged, or adequate reserves be made therefore. The known liabilities for which reserves must be established are set forth in Exhibit 1.

3. Assets Requiring Return, Transfer or Conveyance. All assets held by the corporation upon condition requiring return, transfer, or conveyance, which condition occurs by reason of this dissolution shall be returned, transferred, or conveyed in accordance with such requirements. All known assets meeting this requirement are described in Exhibit 2.

4. Assets Held Subject to Use Limitations. All assets received and held by the corporation subject to limitations permitting their use only for charitable, religious, eleemosynary, benevolent, educational, or similar purposes, but not held upon a condition requiring return, transfer, or conveyance by reason of the dissolution, shall be transferred or conveyed to the Citrus Levy Marion Regional Workforce Development Board, Inc. A schedule of all known assets meeting this requirement is attached hereto as Exhibit 3.

5. Other Assets. All remaining assets shall be distributed to those persons, trusts, societies, organizations, or domestic or foreign corporations, whether for profit or not for profit, as specified in Exhibit 4.

6. Filing of Plan. A copy of this Plan of Distribution, authenticated by an officer of the corporation and containing the officer's certificate of compliance with the requirements of subsection 617.1406(2) of the Florida Statutes shall be filed with the Florida Department of State.




