Amendments to Articles of Incorporation:

1. Article I.a - Purpose: The organization is organized exclusively for charitable, religious, educational or scientific purposes under section 501(c)3 of the I or corresponding future federal tax code. Specifically, this organization is geared towards the teaching of performing arts, circus arts, dance and music. This organization offer performing arts classes and performances to the community of Gainesville, Florida and surrounding areas, works in collaboration with many other community organizations for charitable purposes and youth outreach.

Article I.b. – Narrative Description of Activities: Gainesville Circus Center, Inc. is launched as a product of the activities conducted by Corey and Victor Souza under the legal entity S-Connection, LLC since 2007. S-Connection, LLC was originally founded to encompass Corey & Victor Souza's activities as performing artists, performing arts instructors and cultural exchange coordinators. As the business has grown, and diversified, many of the activities of S-Connection, LLC are geared towards educational and charitable events. Thus, arose the necessity to form a non-profit, in order to seek additional support from community, government and private agencies, and to distinguish charitable and educational activities from profitable engagements. Gainesville Circus Center, Inc. will govern activities involving community education and contributions to charitable events.

Gainesville Circus Center, Inc. currently offers circus and dance classes to children and adults in Gainesville, Florida at: 250 SE 10th Ave, 32601. The school holds an average of 25 classes per week, offers scholarships and work-trade opportunities for individuals demonstrating financial need, and recently launched a program in conjunction with a local private school, to teach circus arts to kids with a broad range of learning (dis)abilities: ADD, ADHD, Asperger's, etc. Furthermore, students of Gainesville Circus Center, Inc. receive numerous opportunities throughout the year to participate in community performances, thereby sharpening their artistry, professional skills, and ability to work in a collaborative environment.

It is our goal, as the center continues to grow, that we are able to offer more classes to atrisk youth, whether those risks are based on socio-economic status or learning ability. Numerous studies show the power of circus arts (and performing arts at large), to transform the lives of individuals cognitive, physical and emotional state of being for the

better. It is our goal to be a part of that transformation in this community. Additionally, this organization hopes to contribute to the diversity of performing arts activities in the Gainesville community, by providing quality performances that are accessible to the general public.

Article II - Dissolution: Upon dissolution of this organization, assets will be distributed for one or more exempt purposes within the meaning of Section 501(c)3 of the Internal Revenue Code or future federal tax code, or shall be distributed to federal government, or to a state or local government, for a public purpose.
