

## ARTICLES OF INCORPORATION OF HEALING AND RESTORATION MINISTRIES INTERNATIONAL INC.

The undersigned incorporator being of full age, for the purpose of establishing a Christian Ministry, a non-profit corporation in compliance with chapter 617, F.S; adopts the following articles of incorporation.

#### ARTICLE I NAME

The name of the corporation shall be: HEALING AND RESTORATION MINISTRIES INTERNATIONAL INC. The effective date shall be January 10<sup>th</sup> 2018.

#### ARTICLE II PRINCIPLE OFFICE

The principle place of business and mailing address of this corporation hall be:

### ARTICLE III PURPOSE

The purposes for which the corporation is organized are to engage in, assist, and contribute to exclusively religious, charitable, educational activities and projects. In order to support such objectives, the primary activity of the corporation shall include but are not limited to:

- a. Uncompromisingly preach and propagate the Word of God, present salvation to humanity as well as edify the body of Christ. (Matthew 28:19-20, Mark 16:15, Luke 4:8-18, II Corinthians 7:14; Ephesians 4:15; Colossians 1:5-6; I Timothy 2:7; II Timothy 2:1-2, 4:2)
- b. Fulfill God's mandate to minister to the widows and the orphans. (James 1:27; 1 Timothy 5:3). Protect them from being neglected. (Acts 6:1-7). Feed and care for them (Deuteronomy 24:19; Deuteronomy 24:20-21; Deuteronomy 26:12; Isaiah 1:17; Jeremiah 22:3; Zechariah 7:10). (Psalm 68:5; Exodus 22:22; Deuteronomy 10:18; Jeremiah 49:1; 'Deuteronomy 27:19; Psalm 146:9; Isaiah 1:23). Minister to them physically, spiritually, financially in ways that will

improve their lives and wellbeing. (Deuteronomy 14:29) We are admonished by Scriptures not to pervert the judgment of the stranger, the fatherless; or the widow, or oppress, harass, discriminate against them or cheat them. (Deuteronomy 24:17). Neglecting them grieves God. (Isaiah 10:2; Jeremiah 5:28). Jeremiah 49:11; Ezekiel 22:7; Malachi 3:5), (Psalm 82:3, Deuteronomy 16:11).

- c. Establish auxiliary clubs and religious societies to promote Christian fellowship in the body of Christ; (II Timothy 2:2, 15). Establish Christian centers, Christian academic institutions, nationally and internationally to standards set forth by the Bible (Proverbs 8:10, Matthew 28:19-20, Mark 16:15-16, Luke 24:47, II Timothy 2:2, 15).
- d. Provide Scholarships to qualified underprivileged children and students of all ages to attend institution of learning so they can be knowledgeable and become productive members of the society.
- e. Organize evangelistic crusades locally and internationally to propagate the love, healing and saving power of Jesus Christ to all nations; Send forth home and foreign missionaries to spread the gospel throughout the world.
- f. Organize community outreaches in order to raise awareness and bring transformation through the gospel. Significantly reduce the horrendous rate of juvenile delinquency, moral laxity, rise of gangs, alcohol and drug addiction, and other social ills that are plaguing our communities (Isaiah 5:11, Habakkuk 2:15, Joel 2:32, Matthew 9:12, Psalms 121:2).
- g. Use the gospel to reach various facets of humanity through marriage, singles, and youth conferences, seminars, workshops, and other outreaches that would empower them to maximize their potentials.
- h. Provide individual and group counseling to the battered or physically abused, emotionally traumatized, the impoverished, and the vulnerable so they may be empowered with Truth to overcome life challenges and embrace healing and restoration.
- i. Provide mentoring, networking, impartation, materials, and support to local and international Pastors, Prophets, Apostles, Evangelists. Teachers, church workers, and ministry leaders to empower them to do the work of the ministry.
- j. Print, publish, distribute and sell books, magazines, and other literatures; make and distribute Christian films; record, reproduce, and distribute videos,

- DVD'S; use any and all media, including but not limited to radio or television in connection with the purpose of the corporation.( I Chronicles 16:23-24)
- k. Do charitable work for the poor and lost (Leviticus 25:35; Matthew 25:34-40; Galatians 6:10); such as open food pantries/soup kitchens for the hungry, clothing closet, prison ministry, (Psalms 142:7, 146:7, Luke 4:18); after-care center for released prisoners (Psalms 69:3, Isaiah 49:9-10); sick and shut in ministry, un- wed mother's home (Luke 4:18); abused wives and children's home, (Deuteronomy 10:18, Acts 6:1.1Timothy 5:3-12, 16); housing for the homeless and runaways (Leviticus 25:35, Luke 3:11, II Corinthians 8:14-15); housing for those with addictive behavior (Luke 4:18); for the elderly (Psalms 92:14, 1Timothy 5:1, 5:17 Exodus 20:12); for the mentally challenged (Matthew 4:24, 17;15-18). Care for and assist handicapped individuals (Leviticus 19:14, Isaiah 35:5, Mark 7:37, Luke 14:3-14); and those who are less fortunate in difficult situations or the vulnerable.
- 1. Have the right to own, purchase or acquire by gift, bequest, or otherwise, either directly or as a trustee, and to own, hold in trust, use, sell, convey, mortgage, lease, or otherwise dispose; of any real estate or personal property as may be necessary for the furtherance of the gospel. (Ezra 8:28; James 1:17, I Peter 4:10-11, Acts 2:44-45
- m. Disseminate the good news of the gospel through religious, educational, and charitable activities as the corporation seems fit, necessary and/or appropriate from time to time. Fulfill the above purposes, and all other acts and things that are not documented here; and to exercise all other rights and powers which may be relevant to accomplishing any and/or the ongoing aims and objective of the corporation.

### ARTICLE IV BOARD OF DIRECTORS/MANNER OF ELECTION

- a. The corporation shall be managed by a board of directors. The number of the board of directors shall be determined by the Bylaws of the corporation and may be altered by amending the Bylaws, but shall never be less than required by law.
- b. The term of office of the board of directors shall be fixed by the Bylaws of the corporation and may be altered by amending the Bylaws. But, the term of office of the board of directors shall not be less than 1 year. Members of the board of directors shall serve until the end of the term fixed by the Bylaws at

which they may either be reelected or removed and/or, successors are elected into the office as provided by the Bylaws.

The board of directors shall have regular meetings via on sight or live/virtual conference or teleconference sessions as stipulated by the byelaw and co-labor in collaboration with the Lord to run the administration and fulfill the vision for which the organization was founded. The byelaw shall define the duties of each board of director.

### ARTICLE V STATEMENT OF FAITH

The corporation shall at all times during its existence adhere strictly to a statement of faith as follows:

- a. We accept the entire 66 books of the Bible, as the written word of God. The Bible is an essential and infallible record of God's self-revelation to mankind that leads us to salvation. The Bible is inspired word of God and therefore is free of error in all it teaches. All believers are exhorted to study the scriptures and diligently apply them to their lives. (2Timothy 3:15-17, II Peter 1:21)
- b. We believe that there is one God: Infinite, Eternal, Almighty, and perfect in holiness, truth, and love, eternally existent in three persons: Father, Son, and the Holy Spirit, co-existent, co-equal, co-eternal. (1 John 5:7)
- c. We believe in the deity of our Lord Jesus Christ, in His virgin birth, in His sinless life, in all His miracles, in His atoning death through His shedding of blood to redeem mankind, in His bodily resurrection, in His ascension into the right hand of God and in His second coming to Earth in power and glory. (John 3:16;5:2-23, Hebrews 9:28, Acts 1:9, John 1:14, John21:24-25, 1Corinthians 15:3-4, Hebrews 2:14-17)

- e. We believe in the rapture of the saints "For the Lord himself shall descend from heaven with a shout, with the voice of the archangel, and with the trump of God: and the dead in Christ shall rise first; Then we which are alive and remain shall be caught up together with them in the clouds, to meet the Lord in the air and so shall we ever be with the lord." (1Thessalonians 4:16-17)
- f. We believe in the ministry and the sanctifying power of the Holy Spirit by whose indwelling the Christian is empowered to live a holy life.
- g. We believe in the baptism in the Holy Spirit, Divine healing, the Nine Gifts of the Holy Spirit, five-fold ministry, laying on of hands, Deliverance, Tithing and Offerings as commanded of God to be observed by all and used for the propagation of the gospel according to scriptures (1Corinthians 9:7-14, I Corinthians 12, James 5:13-14, Malachi 3:8-12)
- h. We believe in the ordinances of the church such as:
  - i. Water baptism by immersion as prescribed by the scripture and administered in the name of the Father, the Son, and the Holy Spirit (Matthew 28:19, Acts 8:36-38; 19:35)
  - ii. We believe and observe the Lords supper with unfermented wine and unleavened bread according to Matthew 26:26-28)
- i. We believe in the resurrection of both the saved and the lost; they that are saved unto the resurrection of life, and they that are lost unto the resurrection of damnation; (Matthew 25:34, 41, 46, Revelation 21:8) and the millenger ceign of Christ.
- j. We believe in the spiritual unity and fellowship of believers in our Lord and savior, Jesus Christ.

No member, officer, or director of this corporation shall be personally liable for debts or obligations of this corporation of any nature whatsoever, nor shall any of the property of the members, officers, or directors be subject to the payment of the debts or obligations of this corporation.
