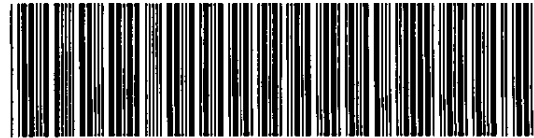

**Article 1. NAME AND ADDRESS**

**Article 2. CORPORATION**

The corporation is organized as a not for profit under State of Florida Statutes.

**Article 3. PURPOSE**

This is a religious corporation with specific purpose to provide a positive Christian alternative to families and communities, through evangelism and teaching of Godly principles and Christian ethics. Provide discipleship and leadership training, lay Christian education and hands-on training to equip those called, to license and oversee ministers of the gospel. To educate and train chaplains to engage the needs of the community. This corporation is organized and operated exclusively for religious purposes.

**Article 4. NON PROFIT ORGANIZATION:**

No part of the net earnings of the corporation shall ever inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation and the corporation shall not participate in, or intervene in (including the publishing of distribution of statements) and any political campaign on behalf of any candidate for office.
