Article I. Name

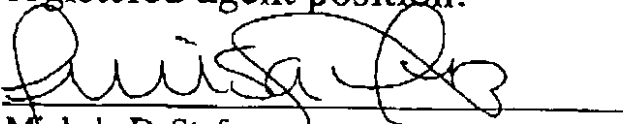
