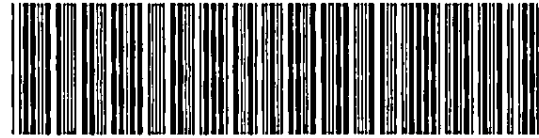

## **ARTICLES OF INCORPORATION**

### **HEART OF CONGO, INC., A FLORIDA NOT-FOR-PROFIT CORPORATION**

#### **ARTICLE I - NAME**

The name of the Not for Profit Corporation shall be **Heart of Congo, Inc.**

#### **ARTICLE II - PRINCIPAL OFFICE & MAILING ADDRESS**
