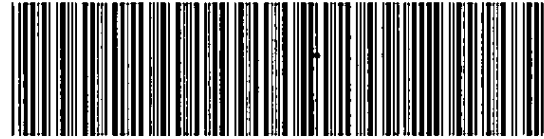

The following articles amendments and articles were added to the Constitution and By-law of Emmanuel Chapel.

1. "Section 1.4: Emanuel Chapel is organized exclusively for charitable, religious, and Christian educational purposes, including, for such purposes, the making of distribution to organizations that qualify as exempt organizations described under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code of United States of America," was added to the Article II (Purpose, Mission and Vision) of the Constitution of Emmanuel Chapel.

2. The Article X (DISSOLUTION) of the Constitution of Emmanuel Chapel was amended as follow;

Emmanuel Chapel is organized exclusively for charitable, religious and Christian educational purposes under the guidelines of Non-Profit and/or religious organization of United States of America. Upon the dissolution of this church, the remaining assets including real properties and all tangible properties shall be distributed to the non-profit Christian organization engaged in the Christian ministry within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
