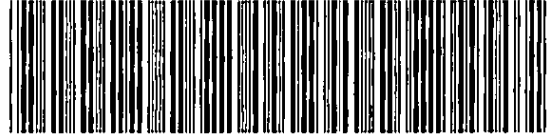

ARTICLE I – NAME

The name of the corporation is:


