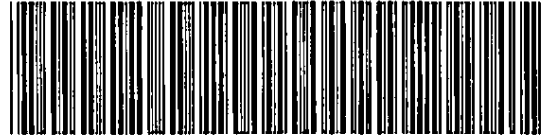

# Articles of Incorporation

## Article I Corporate Name

The name of the corporation shall be:

## Article II Principal Office

## Article III Organization and Purpose

The corporation is organized exclusively for charitable, cultural, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

### Specifically

To establish and maintain an independent Krishna conscious preaching mission:

- To distribute the literatures of His Divine Grace A.C. Bhaktivedanta Swami Prabhupada, extant at the time of his disappearance from this world and authorized by the disciplic succession from Lord Chaitanya Mahaprabhu.
- To encourage and foster the natural bonds of community among individuals and families of similar desire.
- To do all other things necessary and proper in furtherance of the above stated purposes, including but not limited to the creation of communities of physical proximity and virtual online communities, both of which are meant to serve the purposes for which Srila Prabhupada brought the teachings of Sri Krsna out of India.

## Article IV Members

The corporation shall have members as provided in the bylaws of the corporation.

## Article V Election of Directors

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the exempt purposes set forth in these Articles of Incorporation.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### **Article IX                      Dedication and Distribution of Assets**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

In the first instance, such assets shall be distributed to *Krishnaites United Inc.*, a Florida Domestic Nonprofit Corporation (N17000006147).

Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
