

Article III: Purpose

The purpose for which the corporation is organized is to promote the general education of physical and mental health issues while guiding awareness of physical and mental health care options. Established medical professionals with unique cultural experience in underprivileged communities here and in South America will provide related services onsite. Each location is carefully considered for need, as a result of economic hardship or natural disaster and its overall beneficial impact on the community and creating resources for long-term individual health maintenance and support.

Services will be provided at community centers, cultural events, churches, local schools and through a variety of related social media advocating for improving better mental and physical healthcare.

The corporation's goal is to offer free necessary products such as walkers, wheel chairs and other various medical appliances along with medical health classes for mothers and children, motivational classes with life coaches, aerobic classes and physical strengthening classes among an array of other services applied as the need requires to help foster a better understanding in communities to improve the quality of life for the poor.

Salud First Inc., will seek requests through churches and other mission organizations in place and will otherwise operate exclusively for charitable, scientific or educational purposes within the meaning of Sec. 501© (3) of the Internal Revenue Code of 1986, as amended (the "Code")of which operations:

- 1. No part of the net earnings of the Corporation shell inure to the benefit of, or be distributed to, its members, board of directors, officers, or other persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth herein;
- 2. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidates for public office except as authorized under the code:
- 3. Notwithstanding any other provisions of these articles, the Corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal Income Tax under Sec. 501 (c) (3) of the Code (or the corresponding provisions of any future United States Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under sec Sec.170 (c)(2)of the code (or corresponding provisions of any future United States Internal Revenue Law).
