The corporation does indemnify any directors, officers, employees, incorporators, and members of the corporation from any liability regarding the corporation and the affairs of the corporation,

unless the person fraudulently and intentionally violated the law and/or maliciously conducted acts to damage and/or defraud the corporation, or as otherwise provided under applicable statute.

ARTICLE 11

Purpose

- (a) The purpose of the corporation is exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the internal revenue code, or the corresponding section of any future federal tax code.
- (b) Amelia Foundation seeks to end poverty in Dade City, Florida through educational promotion. The main focus of the Amelia Foundation is Christ. We believe that God wants His widows and orphans to not live in poverty. We believe that the first way out of poverty is the gospel of Christ, which will raise people out of spiritual poverty. The second way out of poverty, more specifically monetary poverty, is through the tool of education. This is why currently our main focus is raising money for scholarships. The specific objectives and purpose of this organization shall be:
 - 1) to provide scholarships to the underprivileged youth of Dade City, Florida.
 - 2) to begin after school tutoring programs for underprivileged students free of charge.
 - 3) To provide free music lessons to students k-12.
 - 4) to open a "dream center" where we will eventually have feeding programs, homeless shelter, job training and placement, free and reduced mental health services, and medical health care.
 - 5) to, after each of the previous goals are met, expand our horizons to other parts of Florida and elsewhere.
 - 6) to sponsor, host and/or participate in events and activities that promote the Amelia Foundation and its activities.
- (c) In carrying out such Charitable Purposes, the Corporation shall have all of the powers and authorities granted by law pertaining to corporations not for profit, including the power and authority to accepts gifts, devises and other contributions for Charitable Purposes, to buy and sell real and personal property, or an undivided interest therein, to lease property, to hold, administer, invest and reinvest the funds and properties received and to expend, contribute and otherwise dispose of funds or properties for Charitable Purposes either directly or by contribution to other organizations organized and operated exclusively for Charitable Purposes; provided, moreover, that such powers and authorities shall be exercised only in furtherance of Charitable Purposes as permitted under Chapter 617, Florida Statute and under Section 501(c)(3) of the internal revenue code.

ARTICLE 12 Prohibited Activities

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 11. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

ARTICLE 13 Distributions Upon Dissolution

Upon the dissolution of the corporation, after paying or making provisions for the payment of all the legal liabilities of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine which are organized and operated exclusively for such purposes.
