The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby presents these Articles for the formation of a corporation under the laws of the State of Florida.

ARTICLE I: NAME

The name of the corporation is SOBER LYFE, INC.

ARTICLE II: PLACE OF BUSINESS

ARTICLE III: PURPOSE

The nature and purpose of the corporation is to establish and operate program(s) that provides inspiration and hope to drug addicts and alcoholics, as well as encouraging those in recovery, to help and serve their community. The program is exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV: NONDISCRIMINATORY POLICY

Sober Lyfe, Inc. has a racial non-discrimination policy. The program admits individuals of any race, color, national and ethnic origin to all rights, privileges, programs, and activities generally accorded or made available to the individuals being served. It does not discriminate on the basis of race, color, national or ethnic origin in administration of its admissions policies, and administered programs. Services provided by Sober Lyfe, Inc. is privileged. Sober Lyfe, Inc. reserves the right to suspend or remove individuals from the program, in accordance with the official policies determined by the Sober Lyfe, Inc. Board.

ARTICLE V: ELECTION OR APPOINTMENT OF DIRECTORS

The corporation shall have at least three (3) directors. Said directors shall be elected or appointed in accordance with the By-Laws.

The number of Directors may be increased or decreased from time to time by the Amendment of the By-Laws, but no decrease shall have the effect of shortening the term of any incumbent Director. The number of Directors shall never be less than three (3).

ARTICLE VI: INITIAL DIRECTORS

Said directors shall hold office until the first annual meeting of the directors, and until their successor(s) shall have been elected and qualified or until their earlier resignation, removal from office or death.

ARTICLE VII: GENERAL FINANCIAL GOVERNANCE

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE VIII: INITIAL REGISTERED OFFICE AND AGENT AND INCORPORATOR

The post office address of the corporation's initial registered agent is 10020 North 25th Street, Tampa, FL 33612, and the name of the initial registered agent at such address is James Chauncey. The Board of Directors may from time to time move the registered office to any other address in the State of Florida.

ARTICLE IX: AMENDMENTS

These Articles of Incorporation may be amended in the manner provided by law.

ARTICLE X: DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction in the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE XI: REGISTERED AGENT

In pursuance of Chapter 48.091, Florida Statutes, the following is submitted in compliance with said act: SOBER LYFE, INC., desiring to organize under the laws of the State of Florida with its principal office located at 10020 North 25th Street, Tampa, FL 33612, has named James Chauncey located at 10020 North 25th Street, Tampa, FL 33612, as its agent to accept service of process within the State.

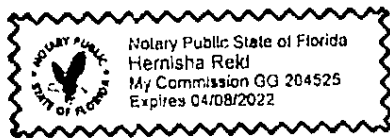
