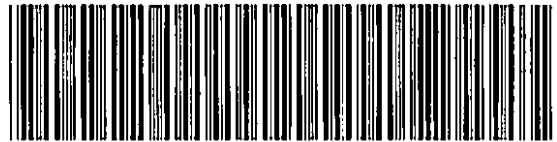

Pursuant to the provisions of section 617.1006, Florida Statutes, MISSION EGLISE EVANGELIQUE DU DIEU DE GOSEN CORP, adopts on October 25, 2018 the following amendment(s) to its Articles of Incorporation:

**ARTICLE I**

**NAME**

The name of this corporation is MISSION EGLISE EVANGELIQUE DU DIEU DE GOSEN CORP

**ARTICLE II**

**DURATION**

MISSION EGLISE EVANGELIQUE DU DIEU DE GOSEN CORP shall have a perpetual existence

**ARTICLE III**

**REGISTERED AGENT**

The name and address of the initial Registered Agent is: David DOUCHARD, 4727 W IRLO BRONSON HWY, KISSIMMEE, FL 34746. The registered Agent is familiar with and accepts the duties and responsibilities as the Registered Agent.

**ARTICLE IV**

**REGISTERED AGENT MAILING ADDRESS**

The initial mailing address of the Registered Agent shall be 4727 W. IRLO BRONSON HWY, KISSIMMEE, FL 34746.

**ARTICLE V**

**PURPOSES**

MISSION EGLISE EVANGELIQUE DU DIEU DE GOSEN CORP is organized and operated exclusively for charitable and education purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. More particularly, to conduct social programs and activities, sponsor research, sponsor promotions, serve the religious community, provide school, and church's temple to underprivileged families in the community. Notwithstanding any other provision of these Articles, MISSION EGLISE EVANGELIQUE DU DIEU DE GOSEN CORP shall not

carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of said Code, or the corresponding provisions of any future statute of the United States. No substantial part of the activities of MISSION EGLISE EVANGELIQUE DU DIEU DE GOSEN CORP shall consist of carrying on propaganda or otherwise attempting to influence legislation; nor shall the corporation participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office. MISSION EGLISE EVANGELIQUE DU DIEU DE GOSEN CORP is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for charitable and education purposes. MISSION EGLISE EVANGELIQUE DU DIEU DE GOSEN CORP is organized and operated exclusively for any lawful purpose to retain nonprofit status as set forth in the most current Internal Revenue Code, and to act and operate exclusively as a not for profit Corporation pursuant to the laws of the State of Florida, its municipalities, county governments, and the United States. The Corporation shall be able to assist and help the community which it serves to achieve other charitable actions such as assisting members of the community who are not financially stable to achieve goals that may render their lives a little better.

## **ARTICLE VI**

### **PUBLICLY SUPPORTED TAX-EXEMPT NONPROFIT CORPORATION**

No part of MISSION EGLISE EVANGELIQUE DU DIEU DE GOSEN CORP shall inure to the benefit of its members, directors, officers, or other private persons, except that MISSION EGLISE EVANGELIQUE DU DIEU DE GOSEN CORP. shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article V hereof. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

## **ARTICLE VII**

### **INITIAL OFFICERS AND DIRECTORS**

## **ARTICLE VIII DISSOLUTION**

The property of MISSION EGLISE EVANGELIQUE DU DIEU DE GOSEN CORP, is irrevocably dedicated to charitable purposes and no part of its assets shall ever inure to the benefit of any director, trustee, member or officer of MISSION EGLISE EVANGELIQUE DU DIEU DE GOSEN CORP, or to any private person. Upon the dissolution or winding up of MISSION EGLISE EVANGELIQUE DU DIEU DE GOSEN CORP, any assets remaining after payment of, or provision for payment of, all debts and liabilities shall be distributed to a governmental entity described in Section 170(b)(1)(A)(v) of the Internal Revenue Code, or to a nonprofit fund, corporation, or corporation which is organized and operated exclusively for charitable purposes, which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code, and which is qualified to receive "qualified conservation contributions" within the meaning of Section 170(h) of said Code, or the corresponding provisions of any future statute of the United States.

## **ARTICLE IX CORPORATE POWERS**

In addition to all other corporate powers provided by law and in furtherance of the objectives described in Article V, but not in limitation thereof, MISSION EGLISE EVANGELIQUE DU DIEU DE GOSEN CORP, shall have the power to:

1. Elect and appoint such officers and agents as its activities shall require and allow them reasonable compensation;
2. Adopt, change, amend and repeal bylaws, not consistent with law or its articles of incorporation; and the exercise of its corporate powers;
3. Conduct its activities, carry out on its operations, and have offices and exercise the power granted by Florida law in any state, territory, district or possession of the United States or any foreign country;
4. Make donations for the public, or for religious, charitable, scientific, educational or other similar purposes;
5. Have and exercise all powers necessary or convenient to effect any or all of the purposes for which MISSION EGLISE EVANGELIQUE DU DIEU DE GOSEN CORP. is organized,

## **ARTICLE X**

## **ARTICLE XI**

### **ADMINISTRATION**

MISSION EGLISE EVANGELIQUE DU DIEU DE GOSEN CORP, is organized, and shall be operated by the Board of Directors, but not limited to the initial directors. The Board of Directors can elect qualified individual in the community to manage the Corporation's affairs according to its bylaws. The board shall make sure that MISSION EGLISE EVANGELIQUE DU DIEU DE GOSEN CORP, assets be used exclusively for the purposes hereinabove set forth in articles V, VI, and IX provided that such does not impair or destroy the tax exempt status to donations, contributions, legacies or dues received by this corporation to the extent that such tax exempt status shall be allowed under any applicable law or regulation.

## **ARTICLE XII**

### **BY-LAWS**

The Board of Directors, by majority vote, is authorized to establish bylaws for MISSION EGLISE EVANGELIQUE DU DIEU DE GOSEN CORP, not inconsistent with these Articles of Incorporation, and to amend same from time to time. Directors shall be elected as stated in the bylaws.

## **ARTICLE XIII**

### **AMENDMENTS TO ARTICLES OF INCORPORATION**

MISSION EGLISE EVANGELIQUE DU DIEU DE GOSEN CORP, reserves the right to amend or repeal any provisions contained in these Articles of Incorporation. Amendments to the Articles of Incorporation must be adopted by an absolute majority vote of the Board of Directors at any board meeting called for that purpose or by the incorporators when necessary.

#### **ARTICLE XIV**

#### **EFFECTIVE DATE**

The effective date of MISSION EGLISE EVANGELIQUE DU DIEU DE GOSEN CORP shall be 02/07/2018.
