Articles of Incorporation Of

Pink Luminous Advocacy Project, Inc. (In Compliance with Chapter 617, F.S., Not for Profit)

Article 1.

The name of the corporation is Pink Luminous Advocacy Project, Inc.

Article 2.

The initial registered office of the Corporation shall be at: 4383 Michigan Ave, Miami Beach, FL 33140. The initial registered agent of the Corporation at such address shall be: Marylin Dans.

Article 3.

Article 5.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
