

## ARTICLE III PURPOSE The purpose for which the corporation is organized is:

Pooches & Kitties In Hollywood, Inc. is a volunteer organization which functions out of the City of Hollywood Code Compliance Division. We are comprised of City of Hollywood employees as well as civilians, who have submitted an application and met the qualifications.

This program has three (3) primary functions. First, Hollywood Police Department Police Officers and other City employees routinely come into contact with lost, abandoned, neglected, abused pets, to include but not limited to dogs, cats, birds, ferrets, pot belly pigs, rats, snakes, hedgehogs, rabbits. Once the pet is contained, the pet will be brought to a City owned facility. Medical care will be provided to the pet as needed. Several attempts will be made to locate the owner of the pet in an attempt to reunite them. The individual must provide proof of ownership and there must be no signs of animal abuse. If the owner is the individual who abandoned, neglected or abused the pet, we will initiate a criminal investigation and the owner will be charged accordingly. If the pet was lost, the animal may be released to its owner. The owner will be charged a \$20.00 a day boarding fee after the first 24 hours. After all attempts to locate the owner have been exhausted, Pooches & Kitties in Hollywood will solicit the animal for adoption. The adoptive family will be asked to pay for all medical bills associated with that animal. In those cases, where the sick or injured cat is from a community cat colony, the cat will be provided with any necessary medical care before being spayed/neutered and returned to the community cat colony.

Second, Pooches & Kitties In Hollywood, Inc. will trap all feral community cats on City owned properties. These cats will be provided with any necessary medical care before being spayed/neutered and returned to community cat colony.

Third, Hollywood Police Department Police Officers and other City employees come into contact with sick, injured or orphaned wildlife, some native, some non-native. Currently, there is no organization to pick up sick, injured or orphaned wildlife (native and non-native) in a timely manner due to a lack of resources. Some are able to be rescued and some or not. This applies to during and after normal business hours. Medical treatment is dependent upon the type of animal, whether native or non-native and the condition of the animal upon arrival at the Wildlife Care Center in Fort Lauderdale. Pooches & Kitties In Hollywood, Inc. will attempt to medically stabilize the native wildlife until the Wildlife Care Center in Fort Lauderdale opens for their normal business hours. For sick, injured or orphaned non-native wildlife, this program will attempt to medically stabilize the non-native wildlife and then find a private animal rescue to assist with the animal.
