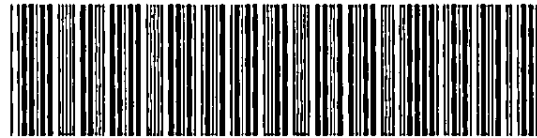

**ARTICLES OF INCORPORATION
OF
FAITHFUL FRIENDS PET RESCUE AND REHOMING, INC.
In Compliance with Chapter 617, Florida Statutes (Not for Profit)**

ARTICLE I: Name

The name of this Corporation shall be FAITHFUL FRIENDS PET RESCUE AND REHOMING, INC., a Florida Not for Profit Corporation.

ARTICLE II: Principal Office

The principal place of business and mailing address of this Corporation shall be 4750 NE 121 Ave, Williston, FL 32696.

ARTICLE III: Purpose

- a) Notwithstanding any other provision of these Articles, the purposes for which this Corporation is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- b) Notwithstanding any other provisions of these articles, this Corporation shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
- c) Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.
- d) In accordance with the above requirements, the specific purpose for which this Corporation is organized is: to save the lives of unwanted companion animals; find new homes for shelter pets through adoptions and rehoming; provide necessary veterinary care to sheltered animals, including sterilization; and promote and support the adoption of shelter pets into good homes.

ARTICLE IV: Manner of Election

The initial Directors of the Corporation shall be appointed by the Incorporator. The manner in which Directors are elected or appointed shall be as stated in the Bylaws of the Corporation.
