# ARTICLES OF INCORPORATION of SPIRIT AND TRUTH CHRISTIAN FELLOWSHIP COMMUNITY OUTREACH MINISTRIES, INC. A not-for-profit Florida Corporation

The undersigned, acting as an authorized member of the Corporation, hereby adopts the following Articles of Incorporation for such Corporation.

#### **ARTICLE I.** NAME - The name of the Corporation is as follows:

## ARTICLE III. <u>PURPOSES/POWERS</u> - The following are the purposes for which the Corporation is organized and its powers.

1. The purposes for which the Corporation is organized and operated are exclusively for religious, charitable, and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provision of any future United States Internal Revenue law.

- As a means of accomplishing the above purposes and 2. methods, in accordance with and in addition to the powers conferred by the laws of the State of Florida, the corporation shall have the following powers:
  - a. Receiving and accepting gifts of money and property and holding the same for any of the purposes of the Corporation and its work.
  - b. Raising and assisting in raising funds for the purposes herein set forth.
  - c. Acquiring, owning, leasing, mortgaging and disposing of property, both real and personal.
  - d. Accepting property and donations in trust for charitable purposes.
  - e. Acquiring, holding, owning, selling, assigning, transferring, mortgaging, pledging, or otherwise disposing of shares of the capital stock, bonds, other securities of obligations or corporations, domestic, or foreign, as investments or otherwise, in carrying out any of the purposes of the Corporation and, while the owner thereof, to exercise all rights, powers and privileges of ownership, including the power to vote thereon.
- In the conduct of the affairs of the Corporation: 3.
  - a. The property of the Corporation is irrevocably dedicated to religious, educational, and charitable purposes, and no part of the net earnings of the Corporation shall inure to the benefit of or be

distributable to its members, directors, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered to it and to make payments and distributions in furtherance of the purposes set forth in this Article.

- b. No substantial part of the activities of the Corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, nor shall it in any manner or to any extent participate in, or intervene in (including the publishing or distributing of statements) any political campaign on behalf of any candidate for public office; nor shall the Corporation engage in any activities that are unlawful under applicable federal, state or local laws.
- c. The Corporation shall not:
  - i. Operate for the purpose of carrying on a trade or business for profit;
  - ii. Accumulate income, invest income, or divert income, in a manner endangering its exempt status; or
  - iii. Except to an insubstantial degree, engage in any activity or exercise any powers that are not in furtherance of the purposes of the Corporation.
  - iv. The Corporation's operations are to be conducted principally in the United States of America; the Corporation also may conduct


operations in foreign countries, subject, however, to the laws of the State of Florida.

#### ARTICLE IV. MANAGEMENT OF CORPORATE AFFAIRS:

The powers of the Corporation shall be exercised by or under the authority of, and the business and affairs of the Corporation shall be managed under the direction of a Board of Directors that shall have eight (8) directors initially. 

#### ARTICLE XIII. MISCELLANEOUS:


- 1. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any activities not permitted to be carried on:

  - b. By a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States internal revenue law).
- In the event of the dissolution of the Corporation, or in the event 2. it shall cease to carry out the objectives and purposes herein set forth, all of the business, property, and assets of the Corporation shall go and be distributed to a non-profit corporation qualifying as an organization exempt under the provisions of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or any superseding status thereof, and as the organization qualifying as a public charity under the provisions of Section 509(a)(1) or 509(a)(2) of the Internal Revenue Code of 1986, as amended, or any superseding statute thereof, as the Directors of the Corporation may select and designate; and in no event shall any of said assets or property, in the event of dissolution thereof, go or be distributed or contributed by such directors for any other such purpose. Any of such assets not so disposed of shall be disposed of by the Circuit Court of the County in which the principal office of the Corporation is then located, exclusively for such purposes, or to such organization or organizations as said court shall determine, which are organized and operated exclusively for such purposes.
