ARTICLES OF INCORPORATION OF

Trusting the Process FL, Inc., a Florida not for profit corporation (the "Corporation"), hereby certifies as follows:

1. The Articles of Incorporation of the Corporation are hereby amended by deleting the present form of Article I in its entirety and by substituting, in lieu thereof, the following:

**ARTICLE I**  
**Name and Address**

The name of the corporation shall be Reach Services, Inc., (the "Corporation"). Pending any change authorized by the Corporation's Board of Directors, its offices shall be located at 6157 31<sup>st</sup> Ave. N., St. Petersburg, Florida 33710.

2. The foregoing amendment shall become effective as of the date of filing with the Florida Department of State, Division of Corporations.

3. The amendment recited in Section 1 above has been duly adopted in accordance with the provisions of §617.0821, Florida Statutes on October 31, 2019, the written action to amend the Corporation's Articles of Incorporation having been approved by the holders of all of the Corporation's directors. The Corporation has no members, and accordingly approval by the Corporation's directors is sufficient to approve the amendment.
