ARTICLES OF INCORPORATION OF  
CENTER FOR BROTHERHOOD AND DEVELOPMENT, INC.  
A FLORIDA CORPORATION NOT FOR PROFIT

ARTICLE I  
NAME

The name of this Corporation will be CENTER FOR BROTHERHOOD AND DEVELOPMENT, INC., hereinafter designated "CFB&DI."

ARTICLE II  
NATURE

CFB&DI is organized as a Florida corporation not for profit, intended to be entitled to non-profit status under Section 501(c)(3) of the Internal Revenue Code of 1986 or corresponding provisions of subsequent federal tax laws exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law, as established and when consistent with Article III below. It is also expressly provided that, notwithstanding any other provision of these Articles, upon the dissolution of the corporation, assets will be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future federal tax code, or will be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of will be disposed of by the Circuit Court the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court will determine, which are organized and operated exclusively for such purposes.

ARTICLE XIII  
INDEMNIFICATION OF OFFICERS AND DIRECTORS

CFB&DI hereby agrees to indemnify any director or officer made a party or threatened to be made a party to any threatened, pending or completed action, suit or proceeding:

- a. Whether civil, criminal, administrative, or investigative, other than one by or in the right of CFB&DI to procure a judgement in its favor, brought to impose a liability or penalty on such person for an act alleged to have been committed by such person in his capacity as director, officer, employee or agent of any other corporation, partnership, joint venture; trust or other enterprise which he/she fines, amounts paid in settlement and reasonable expenses, including attorneys' fees, actually and necessarily incurred as a result of such action, suit or proceeding or any appeal therein, if such person acted in good faith in the reasonable interest of CFB&DI, such action was in the best interest of the reasonable ground for belief that such action was unlawful. The termination of any such action, suit or proceeding by

judgment, order, settlement, conviction or upon a plea of nolo contendere or its equivalent will not in itself create a presumption that any such director or officer did not act in good faith in the reasonable belief that such action was in the best interest of CFB&DI or that he/she had reasonable grounds for belief that such action was unlawful.

- b. By or in the right of CFB&DI to procure a judgement in this favor by reason of his being or having been a director or officer of CFB&DI, or by reason of his being or having been a director, officer, employee or agent of any other corporation, partnership, joint venture, trust or other enterprise which he/she served at the request of CFB&DI, against the reasonable expenses, including attorneys' fees, actually and necessarily incurred by him in connection with the defense or settlement of such action, or in connection with the defense or settlement of such action, or in connection with an appeal therein if such person acted in good faith in the reasonable belief that such action was in the best interest of CFB&DI. Such person will not be entitled to indemnification in relation to matters to which such person has been adjudged to have been guilty of gross negligence or misconduct in the performance of his duty to CFB&DI unless, and only to the extent that, the court, administrative proceeding is held will determine upon application that, despite the adjudication of liability but in view of all circumstances of the case, such person is fairly and reasonable entitled to indemnification for such expenses which such tribunal will deem proper.
- c. The foregoing rights of indemnification will not be deemed to limit in any way the powers of CFB&DI to indemnify under applicable law.

#### ARTICLE XIII

#### TRANSACTION IN WHICH DIRECTORS OFFICERS AND MEMBERS ARE INTERESTED

- a. No contract or transaction between CFB&DI and one or more of its directors or officers, or between CFB&DI and any other corporation, partnership, association, officers are directors or officers, have a financial interest, will be invalid, void or voidable solely for this reason, or participates in the

meeting of the Board or committee thereof which authorized the contract or transaction, or solely because his or their votes are counted for such purpose. No director or officer of CFB&DI will incur liability by reason of the fact that he/she is or may be interested in any such contract or transaction.

- b. Interested directors may be counted in determining the presence of a quorum at a meeting of the Board or of a committee which authorized the contract or transaction.
- c. No part of the net earnings of CFB&DI will inure to the benefit of any Member, Director or Officer of CFB&DI or any private individual. Provided, however, that (i) reasonable compensation may be paid for services rendered by any Member, Director or Officer to or for CFB&DI, and (ii) this provision will not prohibit the reimbursement of funds advanced to, for or on behalf of CFB&DI by any Member, Director or Officer when said funds are advanced with the consent and knowledge of CFB&DI, evidenced by the written approval of the majority of the Board, including, without limitation, transportation and other travel expenses.

ARTICLE XIV  
DISSOLUTION OF CFB&DI

- a. Upon dissolution of CFB&DI, all of its assets, remaining after provision for creditors and payment of all costs and expenses of such dissolution, will be distributed to other non-profit corporation(s) devoted to similar goals.
- b. CFB&DI may be dissolved upon a resolution to that effect being recommended by three-fourth (3/4) of the members of the Board, and, if such decree be necessary at the time of dissolution, after receipt of an appropriate decree as set forth in Florida Statutes Section 617.05 or statute of similar import, and approved by two-thirds (2/3) of the voting rights of CFB&DI's members.




