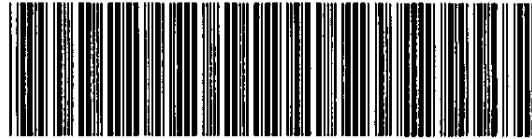

Article III is being amended to read: This corporation is founded exclusively for charitable religious purposes within the meaning of the IRS Code Sec 501(c)(3); namely : To establish and maintain a House of Chabad Orthodox Jewish Worship and there to provide Jewish religious, educational, cultural, social, counseling and other services to the Jewish community according to Orthodox Jewish tradition based on the Code of Jewish Law (Shulchan Aruch) by Shneur Zalman of Liadi and other canonical texts of traditional Judaism and Chabad customs. It will be empowered to contract, rent, buy or sell personal or real property, to provide a place of worship as well as a parsonage for the Chabad Emissary, Aryeh Y Schwartz, who is the Rabbi and spiritual head of the organization and the final authority in all matters pertaining to Ethics, Spirituality and Religious Law. This corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of its primary purpose.

Rabbi Aryeh Y Schwartz, has the sole right to determine which question or issues should be regarded as matters of Ethics, Spirituality and Religious Law.

This corporation is empowered to supply all the foods, religious items and physical constructions/properties required according to Chabad Orthodox Jewish Law, including Religious Articles, Kosher Food, Ritual Immersion Pools, or transportation to any event or location which in the view of the Rabbi is required in the fulfillment of Religious Duties and understood in Jewish and/or Chabad Chassidic Tradition. This corporation will be empowered to charge a price to community members and others to cover the costs, time and expenses making such religious resources available.

This corporation will not have shareholding members. As a synagogue it will have Congregational members eligible for those ritual rights and privileges in keeping with Jewish Tradition as understood by the Rabbi. Membership will be conferred by the directors in consultation with the Rabbi after conducting interviews with the perspective members.

Upon the dissolution of the organization, its remaining assets shall be distributed for one or more organizations with similar exempt purposes recognized under section 501(c)(3) of the Internal Revenue Code.
