# Articles of Incorporation

### Of

Live To Purr Another Day Rescae. Inc. (In Compliance with Chapter 617, F.S., Not for Profit)

# Article 1.

The name of the corporation is Live To Purr Another Day Rescue, Inc.

## Article 2.

The initial registered office of the Corporation shall be at: 2018 CR 543 B, Sumterville, FL 33585. The initial registered agent of the Corporation at such address shall be: Simone Kuska.

# Article 3.

The name and address of the incorporator is:

# Article 4.

### Article 5.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The specific purpose of the organization is to rescue animals.
