
**ARTICLES OF DISSOLUTION
OF
STUDENTS FOR CHANGES INC.**

(a Florida not for profit corporation that has not commenced to conduct its affairs)

Pursuant to the provisions of Sections 617.1401 of the Florida Not For Profit Corporation Act (the "Act"), **STUDENTS FOR CHANGES INC.**, a Florida not for profit corporation (the "Corporation"), hereby files the following Articles of Dissolution for the purpose of dissolving the Corporation:

1. The name of the Corporation is: Students for Changes Inc.
2. The Florida Department of State document number of the Corporation is: N18000002208.
3. The date of filing of the Articles of Incorporation of the Corporation was: February 27, 2018.
4. The Corporation has not commenced to conduct its affairs.
5. No debts of the Corporation remain unpaid.
6. The Corporation has no members.
7. Michael Macleod intends to immediately form a new Florida not for profit corporation with the name "Students for Change Foundation, Inc." and intends to register a fictitious name of "Students for Change" for such new corporation. The Corporation consents to the foregoing actions and for such purpose, releases any claim or right with respect to the phrase or name "Students for Change" or "Students for Changes" or other similar variations.
8. There are no Directors of the Corporation who have ever accepted appointment or served as Directors, and therefore, in accordance with Section 671.1401(1)(a) of the Act, the dissolution is authorized by the incorporator.
9. The dissolution of the Corporation shall be effective upon the filing of these Articles of Dissolution with the Florida Department of State.
