ARTICLES of INCORPORATION
A NONPROFIT CORPORATION**

ARTICLE I.

The name of this corporation is M.BENZ CLUB OF THE VILLAGES INC.

ARTICLE II.

The address of principal office and mailing address of the corporation shall be 4204 YARDHAM TER, THE VILLAGES, FL 32163.

ARTICLE III.

This corporation is organized and operated exclusively as a social and recreation club for the pleasure and recreation of its members and other nonprofit purposes within the meaning of '501(c)(7) of the Internal Revenue Code of 1986 (as amended) or the corresponding provision of any future United States internal revenue law. The social and recreational facilities of this corporation shall not be made available to the general public.

This corporation shall have an established membership of individuals, personal contacts and fellowship. The qualifications, privileges, and responsibilities of members shall be as provided in the bylaws of the corporation.

The Corporation may devote a substantial part of its activities for lobbying purposes (including the publishing or distribution of statements) or otherwise attempting to influence legislation. However, the Corporation may participate or intervene in (including the publishing or distribution of statements) any political or judicial campaign on behalf of any candidate for public office only to an insubstantial degree.

The specific purpose of the corporation is CAR CLUB.

ARTICLE IV.

The manner in which the directors are elected and appointed shall be specified in the bylaws of the corporation.

ARTICLE V.

The names and addresses of the directors for the corporation who shall act until the first meeting or until their successors are duly chosen and qualified are

ARTICLE VI.

The initial registered agent and street address of the corporation in Florida shall be PAUL SORGEN at 1639 Long Loop, THE VILLAGES, FL 32163.

ARTICLE VII.

The name and address of the incorporator is Michael Roth at 4204 Yardham Ter, The Villages, FL 32163.

ARTICLE VIII.

The corporation shall indemnify its directors, officers, employees, and agents to the fullest extent provided by the laws of the State of Florida now or hereafter in force, including the advance of expenses under the procedures provided by such laws.

ARTICLE IX.

No part of the net income or net assets of the Corporation shall inure to the benefit of, or be distributable to, its directors, officers, members or other private persons. However, the Corporation is authorized to pay reasonable compensation for services actually rendered and to make payments and distributions in furtherance of its tax exempt purposes.

Upon the dissolution or winding up of the Corporation, all of the business, properties, assets and income of the Corporation remaining after payment, or provision for payment, of all debts and liabilities of this Corporation, shall be distributed to a nonprofit fund, association, or corporation which is organized and operated exclusively for tax exempt purposes which are reasonably related to the purposes and goals of this Corporation, as may be determined by the Board of Directors of this Corporation in its sole discretion, and which has established its tax exempt status under '501(c)(7) of the Internal Revenue Code of 1986, as amended.

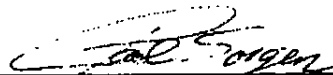
