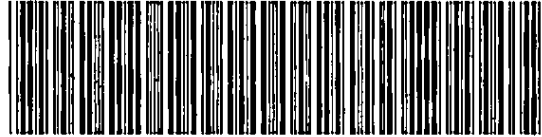

**Articles of Incorporation of  
Childlike Champions Foundation, Inc.**

**In compliance with Chapter 617, F.S., (Not for Profit)**

Article One: Name

The name of the corporation shall be Childlike Champions Foundation, Inc. in honor of the many courageous and valiant children that battle pediatric diseases with a bravery and strength that is unparalleled. It is for them that we all strive to be "Childlike Champions".

Article Two: Principal Office and Mailing Address

The principal place of business will be: Childlike Champions Foundation, 111 Two Pine Drive, Greenacres, FL. 33413.

The mailing address will be: Childlike Champions Foundation, 1751 N. Litchfield Road, #1159, Goodyear, AZ 85395.

Article Three: Purpose

This corporation is a nonprofit organization and is not organized for private gain of any person. It is organized in compliance with Chapter 617 of the Florida Statutes for charitable purposes. The specific purpose of this foundation is threefold. The first tier of our purpose is to support research in finding a cure and/or control for pediatric diseases by building relationships and designating funds to existing nonprofits who have already established great progress in this field. The second tier is to establish a presence in pediatric hospitals to make the hospital stays more pleasant and as comfortable as possible for the children as well as their families. The third and final tier of our purpose is to offer financial and practical support to families who are trying to do the best for their children; as well as to bridge the gap between the needs of these children and their families, and the shortcomings of insurance and the costs of medical care.

This is a corporation organized and operated exclusively for charitable and educational purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code.

Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on 1. By a corporation exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code or 2. By a corporation contributions to which are deductible under Section 170 (c)(2) of the Internal Revenue Code.

No substantial part of the activities of this corporation shall consist of participating or intervening in any political campaign (including the publishing or distributions of statements) on behalf of, or in opposition to, any candidate for public office.
