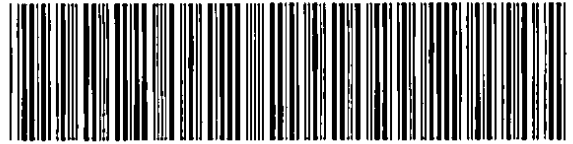


ARTICLE I
