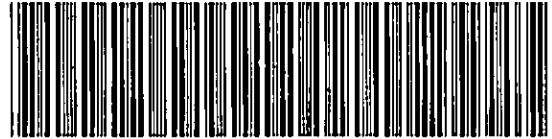



ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I

The name of the corporation shall be The Gregory C. Bradley Charitable Foundation, Inc.
