The Name of the Corporation is **ORANGE RIBBONS FOR GUN SAFETY, INC.** ("Corporation"). The Corporation's Florida Department of State's Document Number is **N18000002812**).

Pursuant to the provisions of section 617.1006, Florida Statutes, this *Florida Not For Profit Corporation* adopts the following amendments to its Articles of Incorporation:

A. Article II of the Articles of Incorporation of Corporation are hereby amended by deleting the mailing address of corporation in its entirety and inserting the following in lieu thereof:

"The new mailing address of Corporation is: 5944 Coral Ridge Drive # 301, Coral Springs, Florida 33076."

B. Article III of the Articles of Incorporation of Corporation are hereby amended by deleting Article III in its entirety and inserting the following new Article III in lieu thereof:

"ARTICLE III

The specific purpose for which this Corporation is organized is:

The purpose for which Orange Ribbons for Gun Safety, Inc. is organized is to promote social welfare within the meaning of section 501(c)(4) of the Internal Revenue Code, including but not limited to: promoting the common good and general welfare of all communities by working to prevent unnecessary deaths from gun violence through education and lobbying activities."

C. The Articles of Incorporation of Corporation are hereby amended by adding a new Article IX to read as follows:

"Article IX"


This corporation shall use its funds only to accomplish the purposes stated in these Articles of Incorporation. Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall be distributed to, and only to, one or more charitable or social welfare organizations."

D. There are no members or members entitled to vote on the amendments. The amendments were adopted by the board of directors in accordance with section 617.1006 (4) and adopted on August 14, 2018.

Corporation has caused these *Articles of Amendment to the Articles of Incorporation of Orange Ribbons For Gun Safety, Inc.* to be executed in its name and on its behalf as of the 14th day of August 2018.
