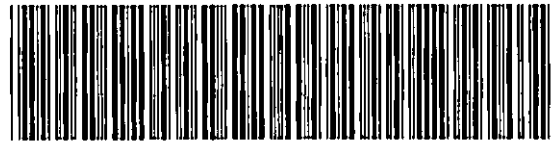

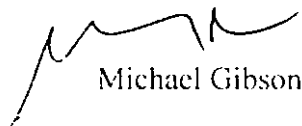

ARTICLES OF INCORPORATION
OF

A Florida Non Profit Corporation

ARTICLE I - NAME

The name of this corporation is Foodraising Friends, Inc.

The duration of this corporation is perpetual.

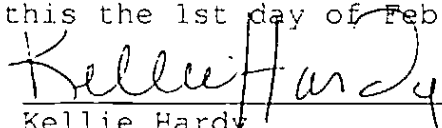
ARTICLE X - BY-LAWS

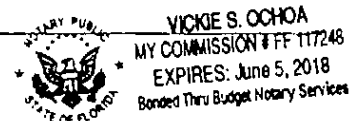

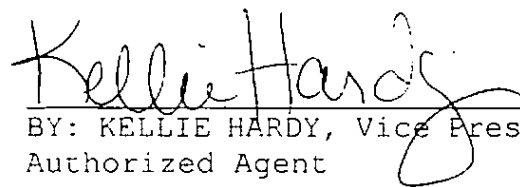

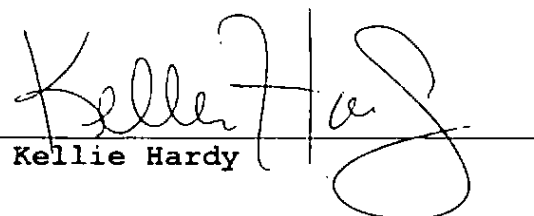
