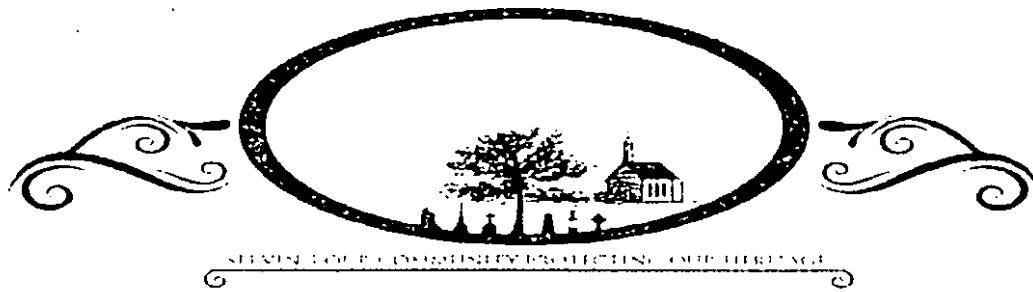

ARTICLE III: PURPOSE

In addition, Hobe Sound Allen Temple Cemetery Archaeological and Cultural Conservation Committee, Inc. shall not be an action Agency (i.e., Hobe Sound Allen Temple Cemetery Archaeological and Cultural Conservation Committee, Inc. shall not attempt to influence legislation as a substantial part of its activities and it may not participate in any campaign activity for or against political candidates) to achieve the Organization's mission and purpose. Upon the dissolution of the Organization, assets shall be distributed for one or more exempt purposes within the mean federal tax code, or shall be distributed to the federal government, or to a state or local government for public purpose. Any such assets noting of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future disposed county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


