ARTICLES OF INCORPORATION OF

START BRIGHT INC

A NONPROFIT CORPORATION ORGANIZED UNDER THE GENERAL CORPORATION LAW OF THE STATE OF FLORIDA PURSUANT TO CHAPTER 617.0202, F.S.

Article I:

The name of the corporation is START BRIGHT INC

Article II:

The principal place of business and mailing address of the corporation is:

Article III:

The specific purpose or purposes of the nonprofit is an organization that seeks to raise funds to provide and support the eleven primary school districts in the Island of St Vincent and the Granadines by providing nutritional breakfast to the children everyday so they are better prepared to learn and develop into strong and healthy adults.

Notwithstanding any provision of this Certificate or any provisions of applicable state law to the contrary, the corporation is not authorized to make any payments or distributions, to engage in regular business of a kind ordinarily carried on for profit or otherwise carry on any activities, which would cause it to fail to qualify, or to continue to qualify, as an organization exempt from federal income tax under section 501(c)(3) of the Code.

Nothing herein shall authorize this corporation, directly or indirectly, to engage in or include among its purposes, any of the activities mentioned in Not-or-Profit Corporation Law, Section 404(b)-(v).

The corporation shall be a Type B corporation pursuant to section 201 of the Not-For-Profit Corporation Law.

No part of the net earnings of the corporation shall inner to the benefit of any member, trustee, director, officer of the corporation, or any private individual (except that reasonable composission may be paid for services rendered to or for the corporation), and no

member, trustee, officer of the corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation.

No substantial part of the activities of the corporation shall be carrying on propaganda, or otherwise attempting to influence logislation (except as otherwise provided by Internal Revenue Code section 501(h), or participating in, or intervening in (including the publication or distribution of statements), any political campaign on behalf of any candidates for public office.

In the event of dissolution, all of the remaining assets and property of the corporation shall after necessary expenses thereof be distributed to another organization exempt under section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent Federal tax laws, or to the Federal government, or state or local government for public purposes, subject to an order of a Justice of the Supreme Court of the State of Florida.

In any taxable year in which the corporation is a private foundation as described in section 509(a) of the Internal Revenue Code of 1986, the corporation shall distribute its income for said period at such time and manner as not to subject it to tax under Section 4942 of the Code and the corporation shall not:

- a. Engage in any act of self-dealing as defined in Section 4941(d) of the Code
- b. Retain any excess business holdings as defined in Section 4943(c) of the Code
- c. Make any investments in such manner as to subject the corporation to tax under section 4944 of the Code or
- d. Make any taxable expenditure as defined in section 4945(d) of the Code or corresponding provisions of any subsequent Federal tax laws.

No part of the net earnings of the corporation shall impre to the benefit of or be distributable to, its members, directors, officers, or other private persons except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of purposes set forth in these articles of incorporation. No substantial part of the activities of the corporation shall be the carrying on of propagands or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Code or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Code.

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for religious, charitable, educational, scientific or literary purposes as shall at the time qualify as an exerupt organization or organizations under Section 501(c)(3) of the Code as the Board of Directors shall determine, or to federal, state, or local governments to be used exclusively for public purposes. Any such assets not so disposed of shall be disposed of by the Superior Court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations,

such as the court shall determine, which are organized and operated exclusively for such purposes, or to such governments for such purposes.
