We, the undersigned incorporators of this corporation under Florida Statue 617, as amended Adopt the following Articles of Incorporation.

**ARTICLE I - NAME**

The name of incorporation is:

**WOMEN OFF THE GRID, INC.**

**ARTICLE II - PURPOSE**

- (A) The purposes for the corporation is organized are exclusively: charitable, scientific, Literary and educational – within the meaning if Section 501 (c) (3) of the Internal Revenue Code of 1996 or the corresponding provision of any future Internal Revenue Law.
- (B) Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Law.
- (C) Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1996, or corresponding section of any future Federal Tax Code, or shall be distributed to the Federal, State, or Local government for public purpose. Any such assets not so disposed of shall be disposed of by the court of Commons Pleas of the county in which the principal office of the organization in then located exclusively for such purposes.

**ARTICLE III – Duration**

The period of the duration of this corporation is perpetual unless dissolved according to law. Corporate existence shall commence upon filing with the Secretary of State.

#### **ARTICLE IV – DIRECTORS**

The requirements for the directors and the manner of their admission are provided for in the By-Laws and Charter.

#### **ARTICLE V – PRINCIPAL OFFICE AND REGISTERED AGENT**


