ARTICLES OF INCORPORATION OF FAITH FOR A FUTURE, INC. A FLORIDA NONPROFIT CORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be: Faith for a Future, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business of this corporation shall be:
