ARTICLE VIII

The assets of this corporation are intended to be devoted to pursuit of the purposes of this corporation and the powers set forth herein are limited to any and all acts necessary to engage in the purposes of ARTICLE III.

ARTICLE IX


At no time may the board of directors or the shareholders of this corporation authorize the corporation to make substantial diversion of corporate income or assets whether by preferential loan, excessive payment, over-compensation or preferential sales or purchases of property, to the incorporator or the incorporators family members, or to a substantial contributor or such contributors family or, to the owner of a 50 percent or greater voting power in the corporation's affairs.
