In compliance with the requirements of AEloridat STATE Statutes, Chapter 617.1001, the undersigned being the E.F. incorporator and President of RUSTY'S BICYCLE RECYCLE, INC., do hereby amend the original Articles of Incorporation:

1. ARTICLE III is amended to read as follows:

## ARTICLE III

The purpose for which the corporation is organized is provide the homeless, the indigent, the poor, the impoverished, the needy, and those without means to purchase same with a form of non-motorized, self-propelled transportation. In addition, this organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify exempt organizations described under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

2. Article VI is amended to read as follows:

## ARTICLE VI

Upon Dissolution the assets of this corporation may not, cannot and will not be distributed to the members of this corporation. Further, upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent

jurisdiction in the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

3. Pursuant to Section 617.1002, Florida Statutes, the foregoing amendment was proposed to the officers and directors at a joint meeting and unanimously approved.
