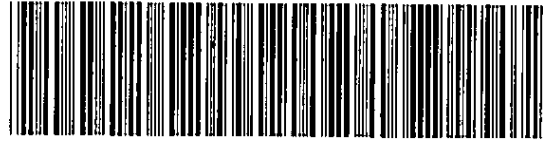

The following is placed at the end of Article III : This corporation is founded exclusively for charitable and educational purposes within the meaning of the IRS Code Sec 501(c)(3); namely : To inform and raise awareness in disadvantaged communities, especially the Haitian community, located in FL, the US and elsewhere, concerning issues related to mental health and the challenges faced by those persons and families who struggle with emotional, psychological, social and developmental issues. Such assistance will include, but not be limited to sponsoring treatment by helping professionals, along with pastoral spiritual based counseling, classes, courses, seminars, social events, home visitations, neighborhood interventions, as well as any other actions which are deemed by the directors to be helpful to the community.

This organization will seek to aid the poor, the distressed, or the underprivileged. It will combat community deterioration and juvenile delinquency. It will work in the general community to promote the understanding and appreciation of those who struggle with mental health issues. It is empowered, at the sole discretion of the CEO or the directors, to provide direct cash grants for the purpose of averting the deterioration of those suffering or their families. The incorporator is the first CEO of this corporation. He shall serve in that capacity until such time as he should become substantially unsuitable for his office, if he should become unable to serve or in the event of his resignation.

The following Article IX is added to the articles of incorporation: In the event of this corporation's dissolution, the directors will --after clearing all debts and liabilities-- distribute any remaining funds or assets to other charitable corporations recognized as such by the IRS under section 501(c)(3) that have similar exempt purposes to those of this corporation.


