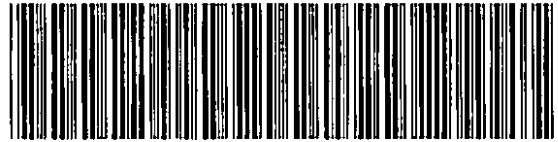

The undersigned incorporator hereby forms a Florida not for profit corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be: **MARCH FOR OUR LIVES PARKLAND, INC.**

The address of the principal office of this corporation shall be 3839 NW Boca Raton Blvd., Suite 100, Boca Raton, Florida 33431, and the mailing address shall be the same.

ARTICLE II. NATURE OF BUSINESS

A. The business may engage or transact in any or all lawful activities or business consistent with the nature of the business of corporations not for profit set forth herein and permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

B. This Corporation is organized and operated exclusively for social welfare within the meaning of Section 501(c)(4) of the Internal Revenue Code, or corresponding section of any future federal tax code. This Corporation shall be a nonprofit corporation. The specific purpose of the organization is:

The nature of the business and the purposes to be conducted and promoted by MARCH FOR OUR LIVES PARKLAND, INC. shall be for: 1) developing and advocating for legislation, regulations and government programs to improve safety in schools and

communities and to protect persons from gun violence; 2) issue-centered education related to safety in public and private facilities and schools; 3) conducting research and publicizing the positions of elected officials; and 5) nonprofit purposes.

- C. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(4) of the Internal Revenue Code.
- D. The Corporation shall not participate or intervene in any political campaign on behalf of, or in opposition to, any candidate for public office to an extent that it would disqualify it from tax exemption under Section 501(c)(4) of the Internal Revenue Code.
- E. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purpose within the meaning of Sections 501(c)(4) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purpose or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purpose.
- F. All references to sections of the Internal Revenue Code shall include such sections as of the date hereof and the corresponding section of any future federal tax code.

ARTICLE III. REGISTERED AGENT/ADDRESS

The street address of the initial registered office of the corporation shall be 3839 NW Boca Raton Blvd., Suite 100, Boca Raton, Florida 33431, and the name of the initial registered agent of the corporation at that address is Michael W. Simon.

ARTICLE IV. TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE V. DIRECTORS

All corporate powers shall be exercised by or under the authority of, and the business and affairs of the corporation managed under the direction of its Board of Directors, subject to any limitation set forth in these Articles of Incorporation and the manner in which Directors are elected is set forth in the corporation By Laws. 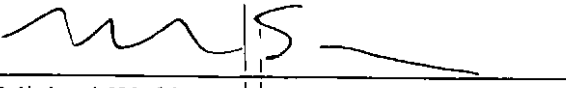

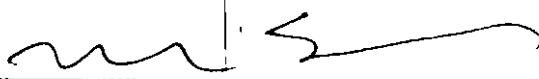
