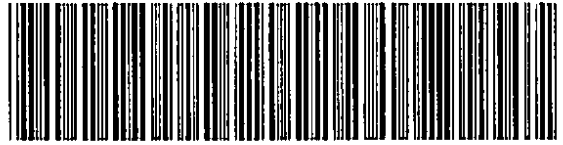

# Florida Nonprofit Articles of Incorporation

## Articles of Incorporation

In compliance with Chapter 617 F.S. (Not for profit)

### Article I Name

The name of the corporation shall be : ONG Teaching with Love Corp

### Article II Principal Office

### Article III Purpose

The corporation is organized with two purposes: 1) To educate, preserve and promote human rights in the same way that they are expressed in the International Bill of Human Rights adopted by the United Nations General Assembly..2) To develop programs to improve life conditions in the populations of the South, Central and North America, serving needs in regard to: Civic affairs, education, the environment, social services and health matters. Including for such purposes under section 501 (c) (3) of the Internal Revenue Code.

### Article IV Manner of Election

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code. (b) by a corporation, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code.

### Article VII Dedication of Assets

Upon the dissolution, termination, or winding up of the corporation, assets shall be distributed for the Church of "Our Lady of Lourdes" of Diocese of Palm Beach. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are organized and operated exclusively for such purposes, within the meaning of section 501 (c) (3) of the Internal Revenue Code.
