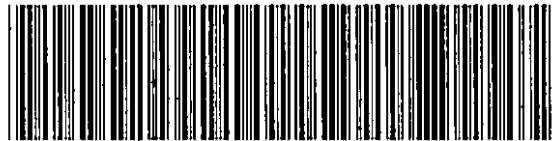

ARTICLES OF INCORPORATION

OF

EXCEPTIONAL STUDENT SCHOLARSHIP ASSISTANCE, INC.

The undersigned incorporator hereby forms a non-profit corporation under Chapter 617 of the Laws of the State of Florida.

ARTICLE I

The name of the non-profit corporation shall be:

EXCEPTIONAL STUDENT SCHOLARSHIP ASSISTANCE, INC.

The address of the principal office of this corporation shall be 3220 N. W. 69th Street, Gainesville, Florida 32606 and the mailing address of the non-profit corporation shall be the same.

ARTICLE II

This corporation is a non-profit corporation and shall operate exclusively for educational and charitable purposes under Section 501 (c) (3) of the Internal Revenue Code or the corresponding section of any future federal tax code.

ARTICLE III

All directors shall be elected by a two-third (2/3) vote of the majority of the members present. A quorum shall consist of seven (7) members.

ARTICLE IV

The street address of the initial registered office of the non-profit corporation shall be 11267 S. W. 34th Road, Gainesville, Florida 32608, and the name of the initial registered agent of the non-profit corporation at that address is Patrick A. Wright.

ARTICLE V

This non-profit corporation is to exist perpetually.

ARTICLE VI

All corporate powers shall be exercised by or under the authority of, and the business and affairs of the non-profit corporation managed under the direction of its Board of Directors, subject to any limitations set forth in these Articles of Incorporation and By-Laws. This non-profit corporation shall have thirteen (13) directors, initially.

ARTICLE VII

ARTICLE VIII

Regular meetings of the non-profit corporation shall be held at such times and places as established by the Board of Directors or as may be provided by the By-Laws.

ARTICLE IX

This non-profit corporation shall have the authority to adopt bylaws to facilitate its operation.

ARTICLE X

Upon a two-third (2/3) vote of the majority of members present and at a meeting that has been noticed for said purposes, this non-profit corporation shall have the authority to amend its articles of incorporation or bylaws. Thirty (30) days written notice must be given to the membership along with a copy of said amendment and said amendment shall be in the form of a recommendation and shall be proposed by the board of directors.

ARTICLE XI

Upon dissolution of this non-profit corporation, all of the assets remaining after the payment of all costs and expenses of such dissolution shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code or shall be distributed to the federal government or to a state or local government for public purposes and no assets shall be distributed to any member, director, officer or trustee of this non-profit corporation.



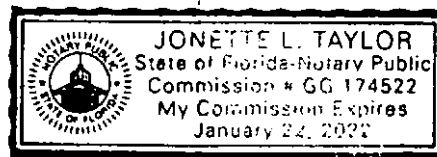
