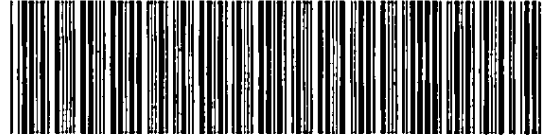

## **ARTICLE III: PURPOSE**

### **Section 1 Nonprofit Purpose**

This corporation is organized and operated exclusively as a social and recreation club for the pleasure and recreation of its members and other nonprofit purposes within the meaning of ' 501(c)(7) of the Internal Revenue Code of 1986 (as amended) or the corresponding provision of any future United States internal revenue law. The social and recreational facilities of this corporation shall not be made available to the general public.

### **Section 2 Specific Purpose**

NSB Pickleball Club provides the opportunity for each and every member to: (1) become more efficient in the playing of the game of pickleball and (2) promote the game of pickleball to individuals or groups of all ages.

The specific objectives and purpose of this organization shall be:

- a. to provide instruction in the game of pickleball;
- b. to engage in an active role in working with cities and counties to provide facilities for the game of pickleball;
- c. to provide opportunities for members to engage in recreational and competitive play;
- d. to sponsor, host and/or participate in events and activities that promote the sport of pickleball;

#### **ARTICLE IV: MANNER OF ELECTION**

There will be an annual meeting of the NSB Pickleball Club and at that time the Board Members shall be elected by the Club Members. Method by which the Board Members of the Corporation are elected shall be stated in the bylaws.



**Attachment to**  
**Articles of Incorporation of**  
**NSB Pickleball Club, Inc.**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
